Transaction Summary

We are providing the rating of WhiteHorse X as a Non-NRSRO rating. The transaction closed on April 16, 2015. It had a reinvestment period, which ended on April 17, 2019. It has a maturity date of April 17, 2027. The deal was refinanced on June 18, 2018. The investments were callable as of December 18, 2018. The Dealer and Trustee were BofA Merrill Lynch and U.S. Bank, respectively. The issued notes are collateralized by 100.0% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -0.0% second lien loans and senior unsecured loans. H.I.G. WhiteHorse Capital serves as the collateral manager.

EJR's weighted average rating score and weighted average life (years) of the collateral were 5451 and 3.42, respectively. 42.7% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 60.39%.

Top 10 Industry Contribution





Stress Analysis



In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's base case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the base case and stress case weighted average whole life default rate of probability can increase to 43.55% and 54.58%, respectively, from its current level of 34.67%.

Estimated Loss Information


Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:

- 2. To reflect the current bearish credit conditions, assets in the collateral pool are assumed to be one notch lower than that currently assigned by other NRSROS.
- 3. The probabilities of default and estimated losses utilized are generally more conservative than industry standards.
- 4. Similarly, the recovery rates applied are lower relative to industry benchmarks.
- 5. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 6. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
