Transaction Summary

We are providing the rating of Zais CLO 1 as a Non-NRSRO rating. The transaction closed on March 27, 2014. It had a reinvestment period, which ended on April 15, 2020. It has a maturity date of November 15, 2028. The deal was refinanced on October 15, 2018. The investments were callable as of October 15, 2019. The Dealer and Trustee were JPMorgan and Bank of New York Mellon Trust Company, respectively. The issued notes are collateralized by 97.56% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 2.44% second lien loans and senior unsecured loans. ZAIS Leveraged Loan Manager serves as the collateral manager.

EJR's weighted average rating score and weighted average life (years) of the collateral were 4949 and 4.09, respectively. 34.75% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 46.19%.







Stress Analysis



In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's base case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the base case and stress case weighted average whole life default rate of probability can increase to 42.17% and 52.54%, respectively, from its current level of 33.2%.

Estimated Loss Information


Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:

- 2. To reflect the current bearish credit conditions, assets in the collateral pool are assumed to be one notch lower than that currently assigned by other NRSROS.
- 3. The probabilities of default and estimated losses utilized are generally more conservative than industry standards.
- 4. Similarly, the recovery rates applied are lower relative to industry benchmarks.
- 5. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 6. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The number of these converted assets is the Diversity Score.

2) The credit rating was based solely upon the merits of the obligor, security, or money market instrument being rated, and

3) The credit rating was an independent evaluation of the credit risk of the obligor, security, or money market instrument.
