### **Transaction Summary**

We are providing the rating of GLM 2017-1A as a Non-NRSRO rating. The transaction closed on April 11, 2017. It had a reinvestment period, which ended on April 20, 2026. It has a maturity date of April 20, 2034. The deal was refinanced on February 19, 2020. The investments were callable as of April 07, 2023. The Dealer and Trustee were Morgan Stanley / Wells Fargo Securities / BofA Merrill Lynch / GreensLedge Capital Markets and Bank of New York Mellon Trust Company, respectively. The issued notes are collateralized by 99.51% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 0.49% second lien loans and senior unsecured loans. GoldenTree Loan Management serves as the collateral manager.


As of August 01, 2021, the total balance of the underlying assets was approximately \$704.15M. The diversity score of the portfolio was 51. EJR's weighted average rating score and weighted average life (years) of the collateral were 3842 and 4.76, respectively. 8.52% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 34.17%.


Top 10 Industry Contribution





#### **Stress Analysis**





In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to 34.61% and 44.13%, respectively, from its current level of 25.17%.

## **Estimated Loss Information**


Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The charts reflects the remaining balance and cashflow forcasting under a).current default and recovery scenario and b). BB (sf) stress level default and recovery scenario, assuming 50% loss will happen evenly in the first year, remaining 50% will happen evenly in the next 4 years. The current principal balance of the tranche is \$8.55M. Under current default and recovery scenario, the payment window for this tranche ranges from October, 2021 to October, 2031, by the end of the payment period (October, 2031), \$8.58M will be paid off. The remaining principal outstanding should be \$1.85M (which represents 21.64% of the tranche balance). Total interest payments of the tranche will total approximately \$6.08M. 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Default Rate and Recovery Rate. According to the methodology, EJR converts the collateral assets into numbers of identical independent assets with the same default rate and recovery rate. The number of these converted assets is the Diversity Score.
