## Transaction Summary

We are providing the rating of GCBSL 2020-48A as a Non-NRSRO rating. The transaction closed on March 24, 2020. It had a reinvestment period, which ended on April 17, 2025. It has a maturity date of April 17, 2033. The investments were callable as of March 24, 2022. The Dealer and Trustee were Credit Suisse and Wells Fargo Bank, respectively. The issued notes are collateralized by $84.68 \%$ senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of $15.32 \%$ second lien loans and senior unsecured loans. OPAL BSL serves as the collateral manager.

As of August 01, 2021, the total balance of the underlying assets was approximately $\$ 539.86 \mathrm{M}$. The diversity score of the portfolio was 48. EJR's weighted average rating score and weighted average life (years) of the collateral were 3930 and 4.61, respectively. $4.14 \%$ of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was $37.94 \%$.

## Stress Analysis

Portfolio Whole Life Default Rate Distribution


In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to $35.92 \%$ and $44.81 \%$, respectively, from its current level of $25.46 \%$.

## Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). Total interest payments of the tranche will total approximately $\$ 13.55 \mathrm{M}$. Under $\mathrm{B}+(\mathrm{sf})$ stress level default and recovery scenario, the payment window for this tranche ranges from October, 2021 to April, 2031, by the end of the payment period (April, 2031), $\$ 17.06 \mathrm{M}$ will be paid off. The remaining principal outstanding should be $\$ 3.84 \mathrm{M}$ (which represents $18.37 \%$ of the tranche balance). Total interest payments of the tranche will total approximately $\$ 13.55 \mathrm{M}$.

## EJR's Key Rating Features \& Differences Compare With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for a more complete description):
