#### **Transaction Summary**

We are providing the rating of LCM XXI as a Non-NRSRO rating. The transaction closed on April 22, 2016. It had a reinvestment period, which ended on October 20, 2020. It has a maturity date of April 20, 2028. The Dealer and Trustee are Deutsche Bank Securities and Deutsche Bank Trust Company Americas, respectively.

As of February 15, 2022, the total balance of the underlying assets was approximately \$219.8M. The diversity score of the portfolio was 49. EJR's weighted average rating score and weighted average life (years) of the collateral were 3740 and 3.3, respectively. Approximately 5.6% of the portfolio's assets were rated CCC+ or less by other NRSROs.


#### Top 10 Industry Contribution







In EJR's view, ratings on loans may be upgraded or downgraded little with notice. In EJR's optimistic case, we assumed an one notch upgrade to the underlying assets. In EJR's stress casees, we assumed one or two notch cut to the underlying assets to reflect possible market pressure. According to EJR's Default Probability Table, the optimistic case, base case, one notch cut and two notches cut casees weighted average whole life default rate of probability are 11.4%, 25.6%, 17.5% and 32.9%, respectively.

#### **Estimated Loss Information**

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:




