Transaction Summary

We are providing the rating of OAKC 2015-12A as a Non-NRSRO rating. The transaction closed on January 13, 2016. It had a reinvestment period, which ended on July 23, 2023. It has a maturity date of July 23, 2030. The deal was refinanced on June 19, 2018. The investments were callable as of July 23, 2020. The Dealer and Trustee were Goldman, Sachs & Co. and Bank of New York Mellon Trust Company, respectively. The issued notes are collateralized by 97.74% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 2.26% second lien loans and senior unsecured loans. Oak Hill Advisors serves as the collateral manager.


As of July 01, 2021, the total balance of the underlying assets was approximately \$580.61M. The diversity score of the portfolio was 62. EJR's weighted average rating score and weighted average life (years) of the collateral were 4099 and 4.65, respectively. 10.83% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 42.18%.


Top 10 Industry Contribution






The underlying assets have maturity dates from June 07, 2023 to January 31, 2029. 14.2% of the underlying assets will mature within 3 years, while another 41.4% of the underlying assets have maturities beyond 5 years.

There are 468 assets in the underlying collateral pool, 97.74% are senior secured loans, and 2.26% with lower seniority.

Stress Analysis



In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to 37.67% and 46.56%, respectively, from its current level of 27.27%.

Estimated Loss Information


Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:





EJR's Key Rating Features & Differences Compare With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for a more complete description):

- 1. Our rating is derived from estimated losses.
- 2. The probabilities of default utilized are generally more conservative than industry standards.
- 3. Generally, our ratings are more heavily model driven and take into account fewer subjective / qualitative assumptions.
- 4. Generally, EJR updates the cashflow and ratings monthly based on the availability of the trustee reports.
- 5. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

Difference Between Implied Rating and Assigned Rating

There is no difference between model implied rating and final assigned rating.

We are using the EJR CLO Methodology (Non-NRSRO) version 1 published by Apr 22, 2020, the General Methodology for Rating Asset Backed and Structured Finance Obligations version 2 published by Apr 26, 2021.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Default Rate and Recovery Rate. According to the methodology, EJR converts the collateral assets into numbers of identical independent assets with the same default rate and recovery rate. The number of these converted assets is the Diversity Score.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:
