Transaction Summary

We are providing the rating of OHA Credit Partners XIII as a Non-NRSRO rating. The transaction closed on December 14, 2016. It had a reinvestment period, which ended on October 21, 2026. It has a maturity date of October 21, 2034. The Dealer and Trustee are GreensLedge / PNC Capital Markets and Citibank, respectively. The issued notes are collateralized by 99.2 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -98.2 second lien loans and senior unsecured loans. Oak Hill Advisors serves as the collateral manager.

Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 3888.1 and 4.5, respectively. Approximately 6.5% of the portfolio's assets were rated CCC+ or less by other agencies. Senior tranche subordination was 33.23%.


Top 10 Industry Contribution





Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). 







According to the methodology, EJR converts the collateral assets into numbers of identical independent assets with the same default rate and recovery rate. The number of these converted assets is the Diversity Score.
