### **Transaction Summary**

We are providing the rating of OHALF 2013-1A as a Non-NRSRO rating. The transaction closed on July 16, 2013. It had a reinvestment period, which ended on July 23, 2023. It has a maturity date of July 23, 2031. The deal was refinanced on March 08, 2017. The investments were callable as of July 23, 2020. The Dealer and Trustee were JPMorgan and Bank of New York Mellon Trust Company, respectively. The issued notes are collateralized by 98.24% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 1.76% second lien loans and senior unsecured loans. Oak Hill Advisors serves as the collateral manager.

As of October 01, 2021, the total balance of the underlying assets was approximately \$490.95M. The diversity score of the portfolio was 61. EJR's weighted average rating score and weighted average life (years) of the collateral were 3987 and 4.86, respectively. 5.51% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 35.82%.




The underlying assets have maturity dates from August 18, 2023 to October 15, 2029. 12.6% of the underlying assets will mature within 3 years, while another 50.2% of the underlying assets have maturities beyond 5 years.

There are 441 assets in the underlying collateral pool, 98.24% are senior secured loans, and 1.76% with lower seniority.

#### **Stress Analysis**



In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to 37.54% and 46.62%, respectively, from its current level of 26.98%.

### **Estimated Loss Information**

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:










