Transaction Summary

We are providing the rating of OZLM XIX as a Non-NRSRO rating. The transaction closed on November 22, 2017. It had a reinvestment period, which ended on January 15, 2027. It has a maturity date of January 15, 2035. The Dealer and Trustee are Citigroup and Citibank, respectively. The issued notes are collateralized by 98.2 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -97.2 second lien loans and senior unsecured loans. Sculptor CLO Management serves as the collateral manager.

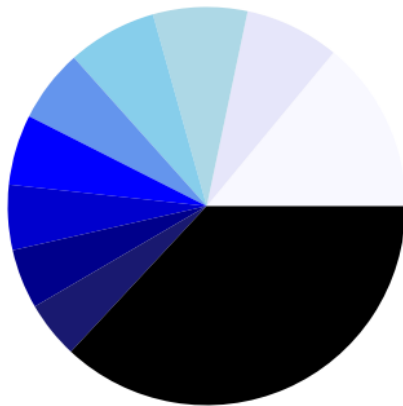
As of May 29, 2023, the total balance of the underlying assets was approximately \$522.2M. The diversity score of the portfolio was 67. Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 3658.5 and 4.8, respectively. Approximately 6.3% of the portfolio's assets were rated CCC+ or less by other agencies. Senior tranche subordination was 33.65%.

Top 10 Industry Contribution

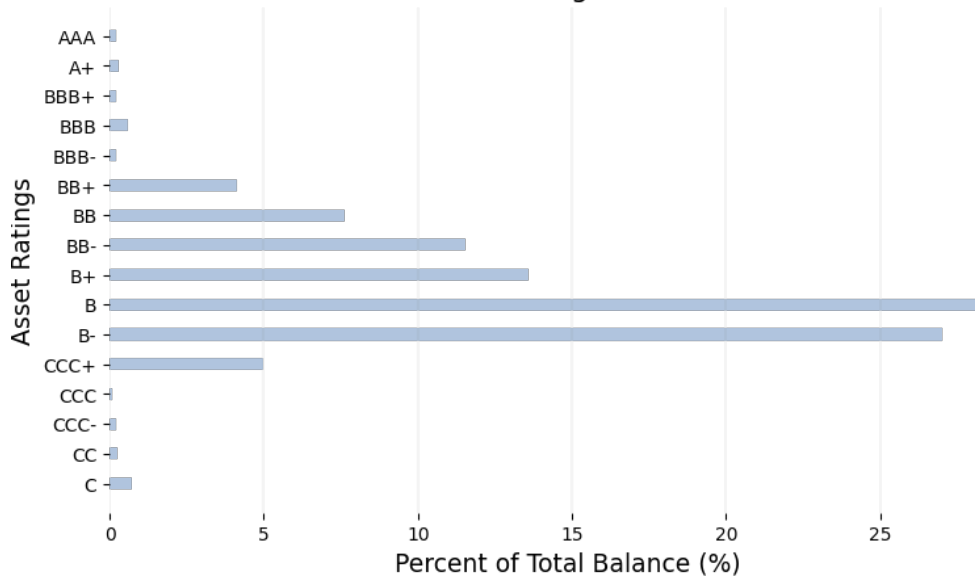

Portfolio Rating Distribution

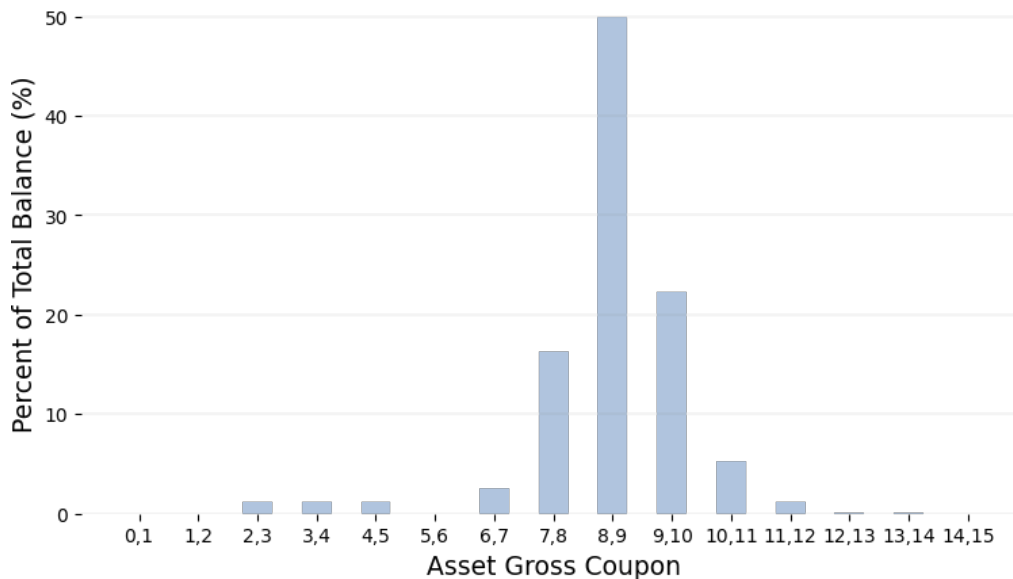

Portfolio Gross Coupon Distribution

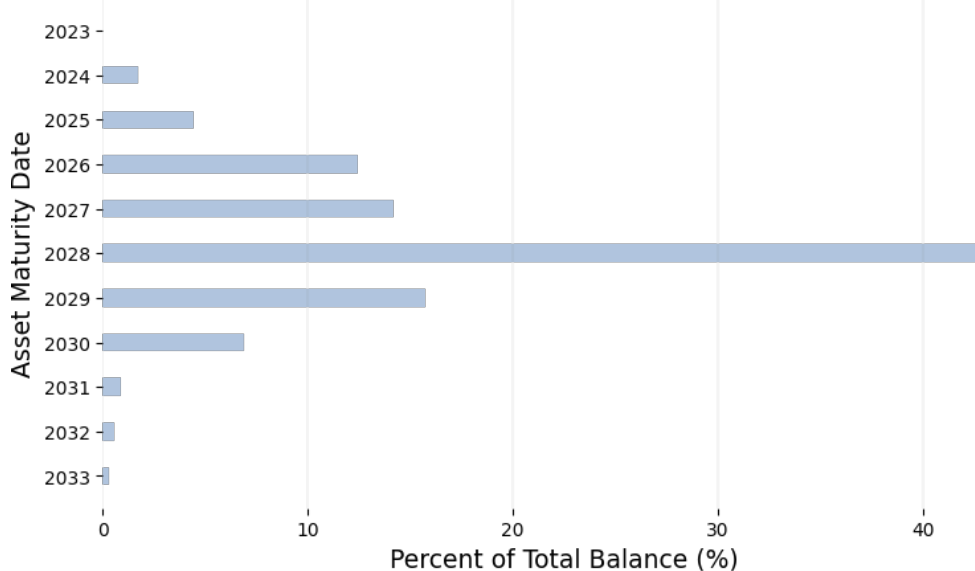

Asset Maturity Distribution



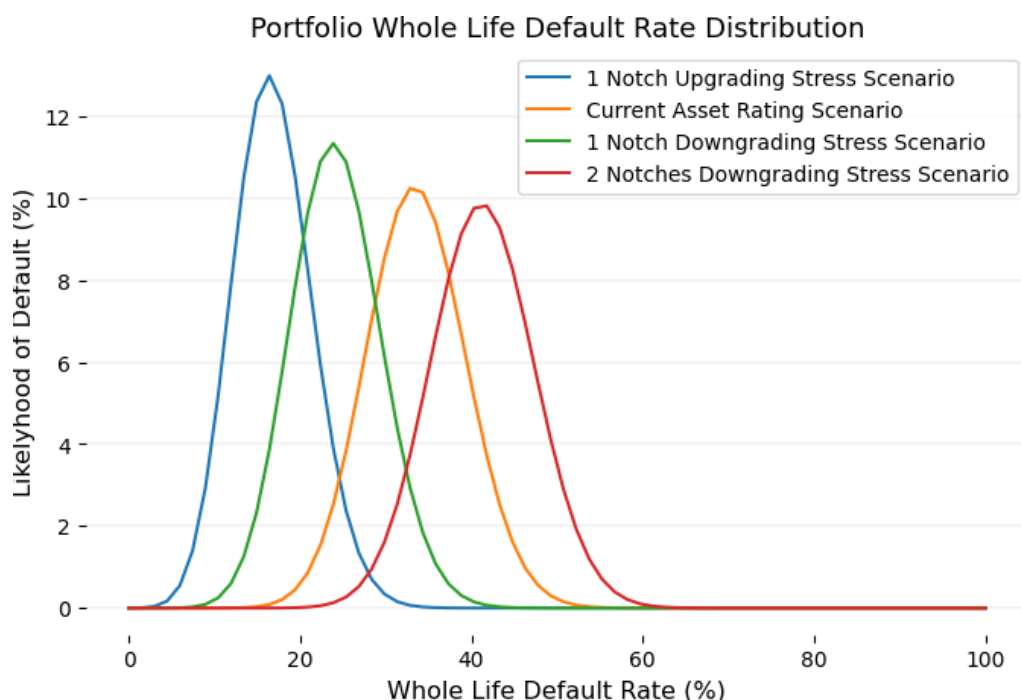

There are 381 non-default assets (with seniority information available) in the underlying collateral pool, 98.2% are senior secured loans, and 1.8% with lower seniority.

Sensitivity Analysis



In EJR's view, ratings on loans may be upgraded or downgraded with little notice. In EJR's optimistic case, we assumed an one notch upgrade to the underlying assets. In EJR's stress cases, we assumed one or two notch cut to the underlying assets to reflect possible market pressure. According to EJR's Default Probability Table, the optimistic case, base case, one notch cut and two notches cut cases weighted average whole life default rate of probability are 16.9%, 33.6%, 24.2% and 41.3%, respectively.

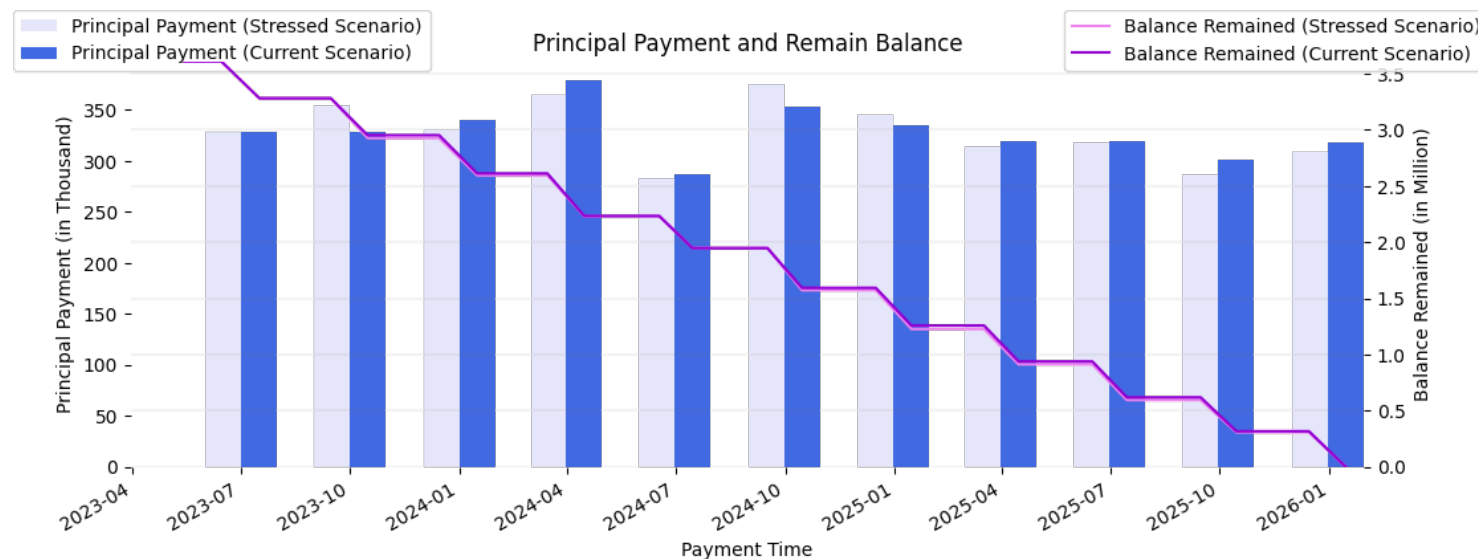
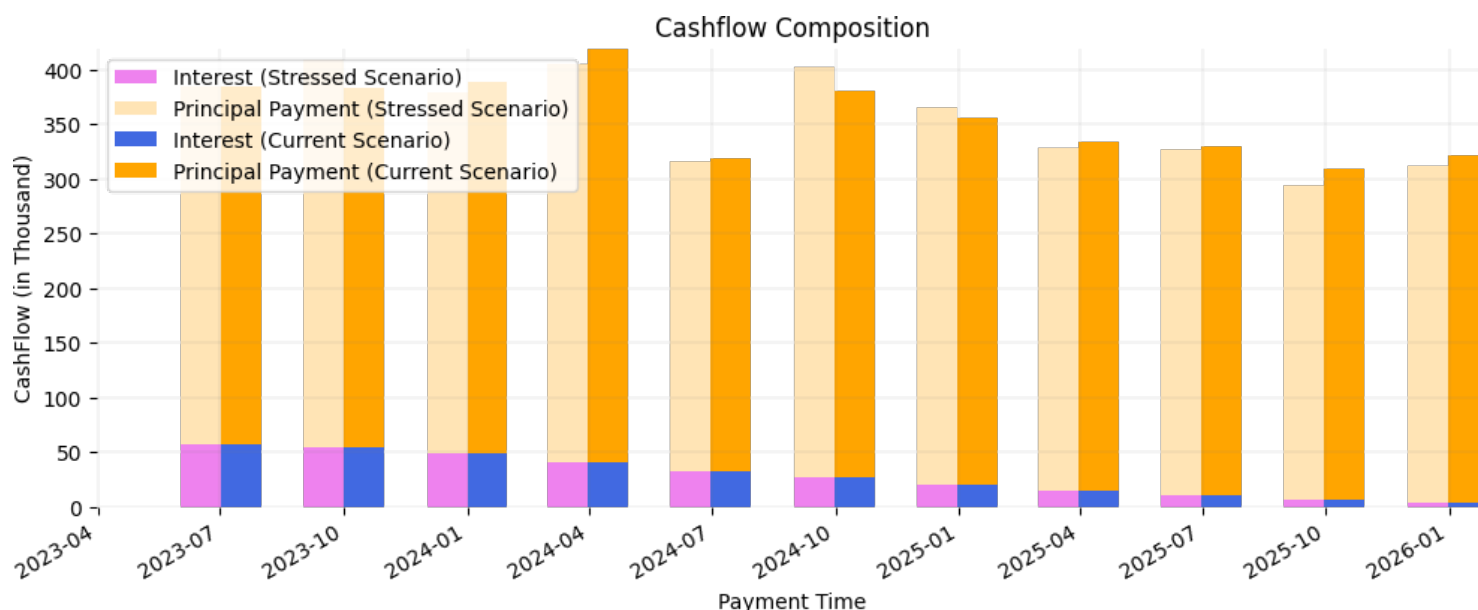
Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). 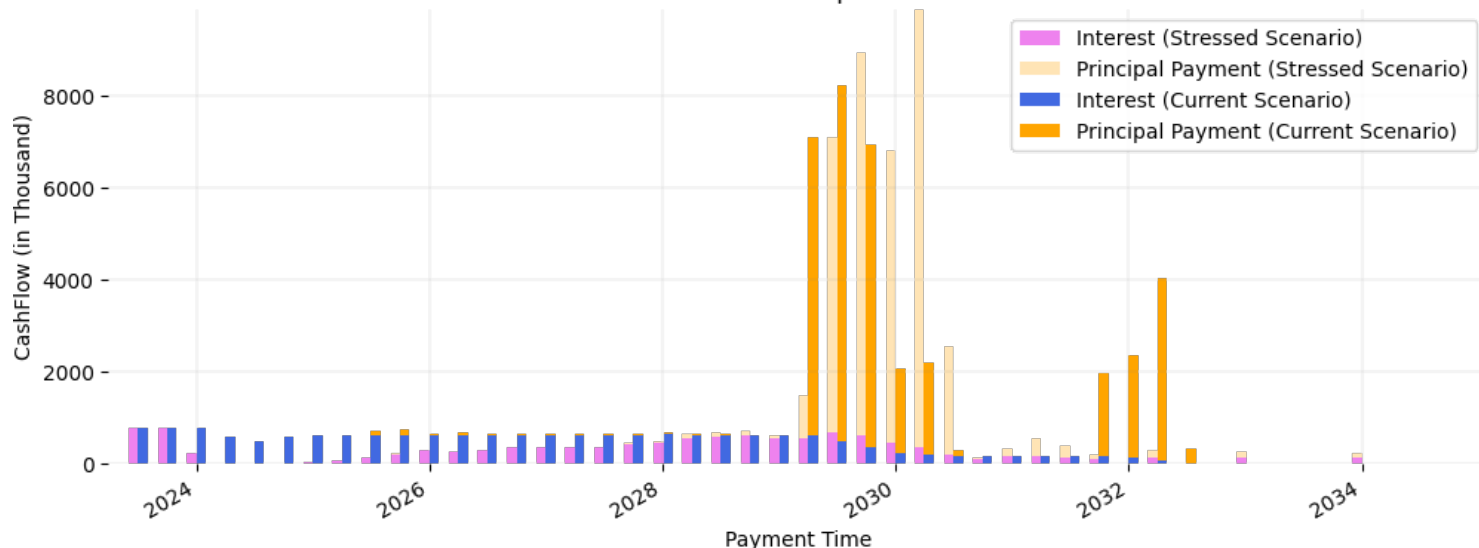

Cashflow Composition



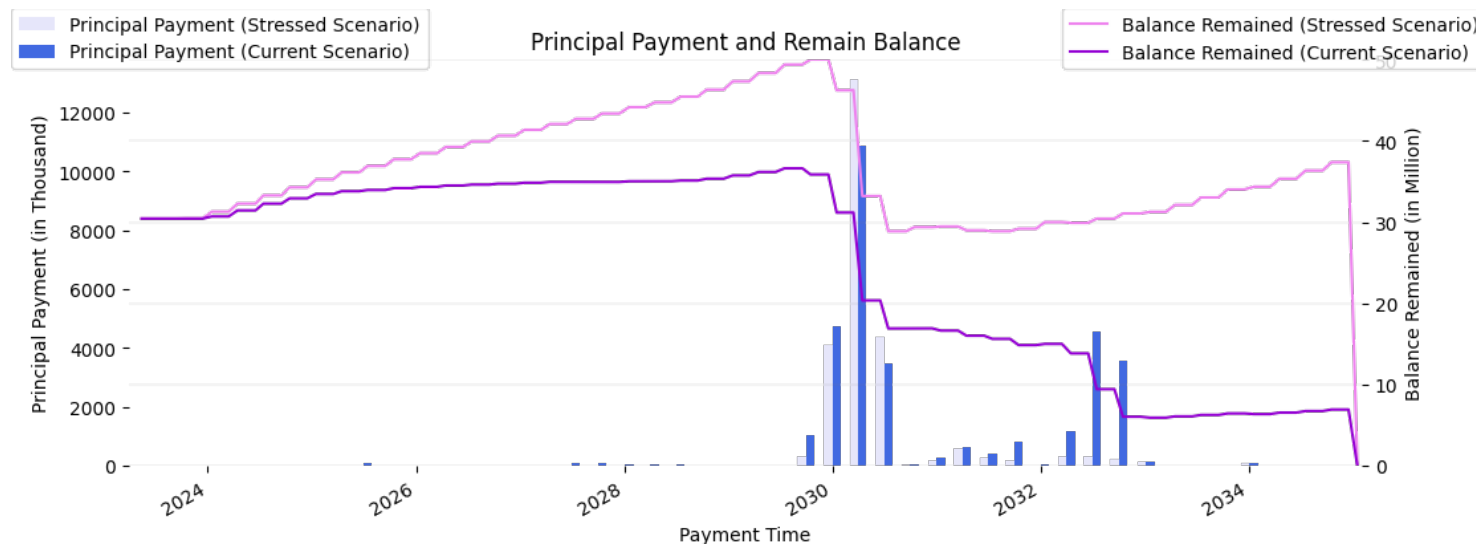
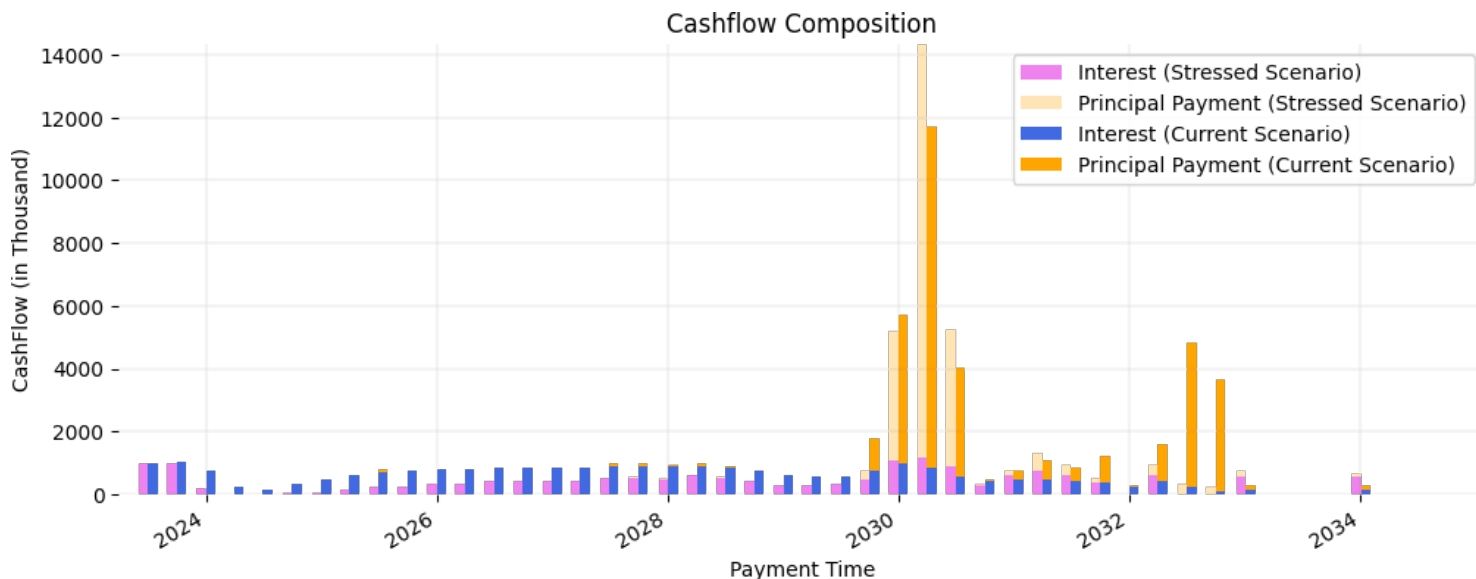

EJR's Key Rating Features & Differences Compare With Other NRSROs

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue.
