Transaction Summary

We are providing the rating of Park Avenue Institutional Advisers CLO 2019-1 as a Non-NRSRO rating. The transaction closed on May 09, 2019. It had a reinvestment period, which ended on May 15, 2024. It has a maturity date of May 15, 2032. The Dealer and Trustee are JPMorgan and U.S. Bank, respectively. The issued notes are collateralized by 99.4 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -98.4 second lien loans and senior unsecured loans. Park Avenue Institutional Advisers serves as the collateral manager.

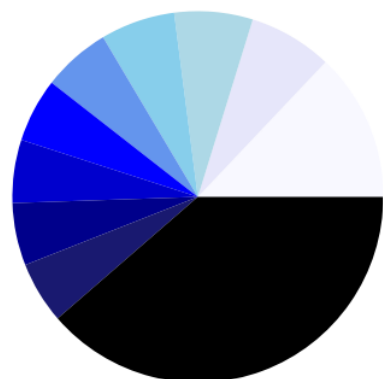
As of April 29, 2024, the total balance of the underlying assets was approximately \$366.1M. The diversity score of the portfolio was 52. Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 3610.4 and 4.0, respectively. Approximately 5.2% of the portfolio's assets were rated CCC+ or less by other agencies. Senior tranche subordination was 34.15%.

Top 10 Industry Contribution



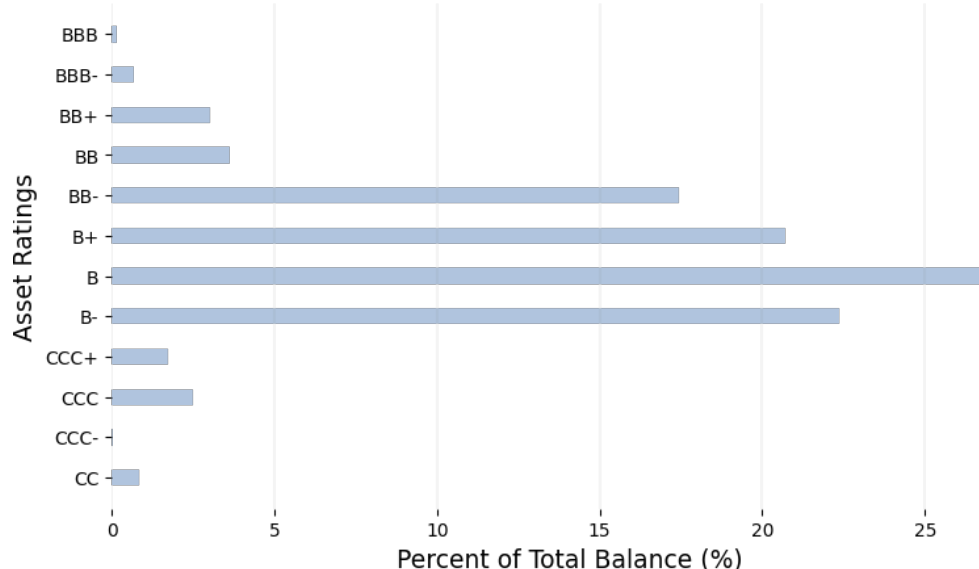

Portfolio Rating Distribution

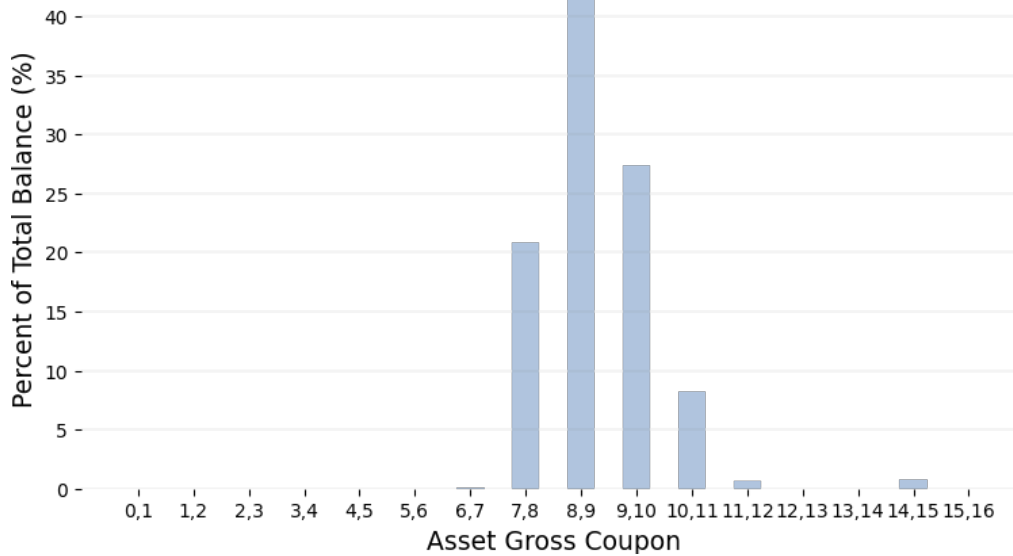

Portfolio Gross Coupon Distribution

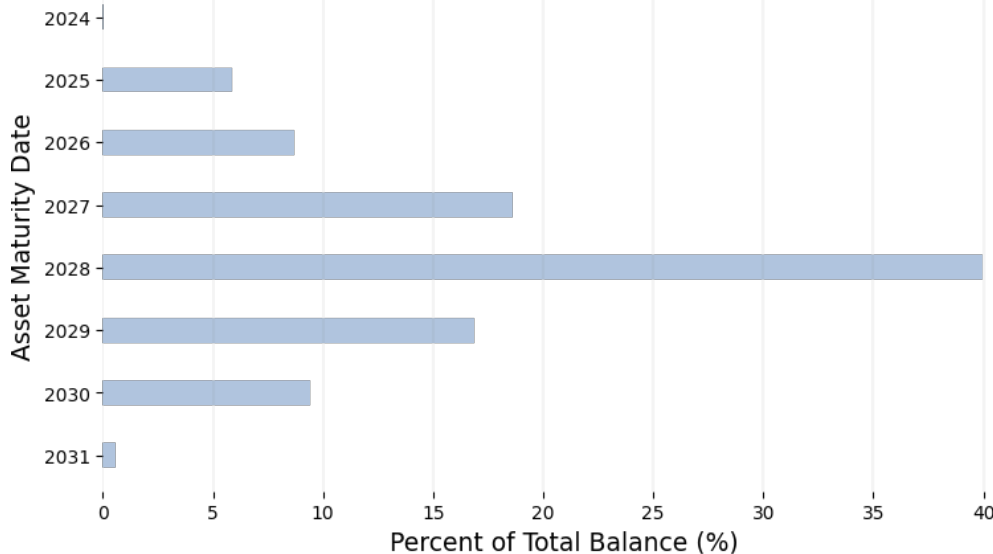

Asset Maturity Distribution



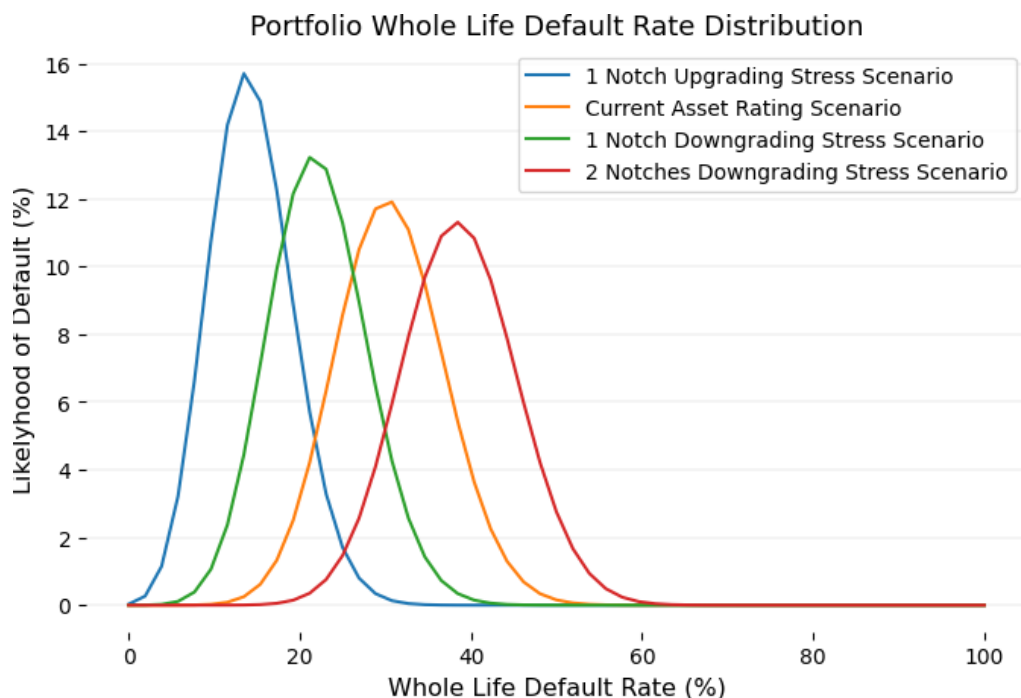

There are 360 non-default assets (with seniority information available) in the underlying collateral pool, 99.4% are senior secured loans, and 0.6% with lower seniority.

Sensitivity Analysis



In EJR's view, ratings on loans may be upgraded or downgraded with little notice. In EJR's optimistic case, we assumed an one notch upgrade to the underlying assets. In EJR's stress cases, we assumed one or two notch cut to the underlying assets to reflect possible market pressure. According to EJR's Default Probability Table, the optimistic case, base case, one notch cut and two notches cut cases weighted average whole life default rate of probability are 14.4%, 30.6%, 22.2% and 38.6%, respectively.

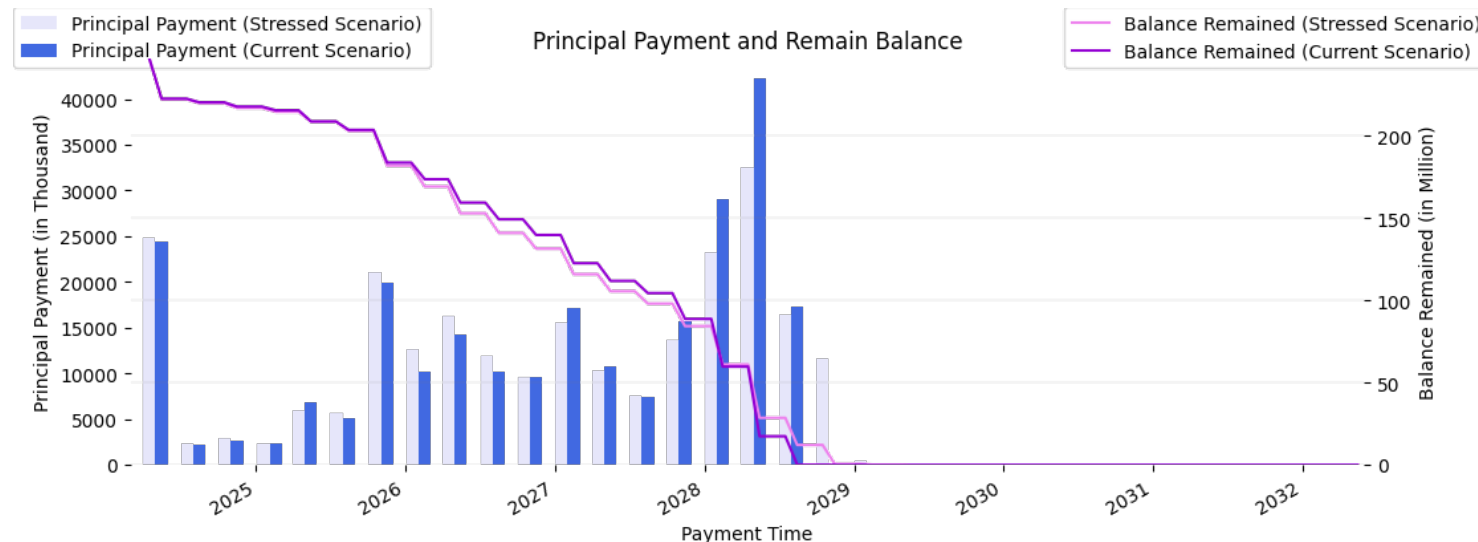
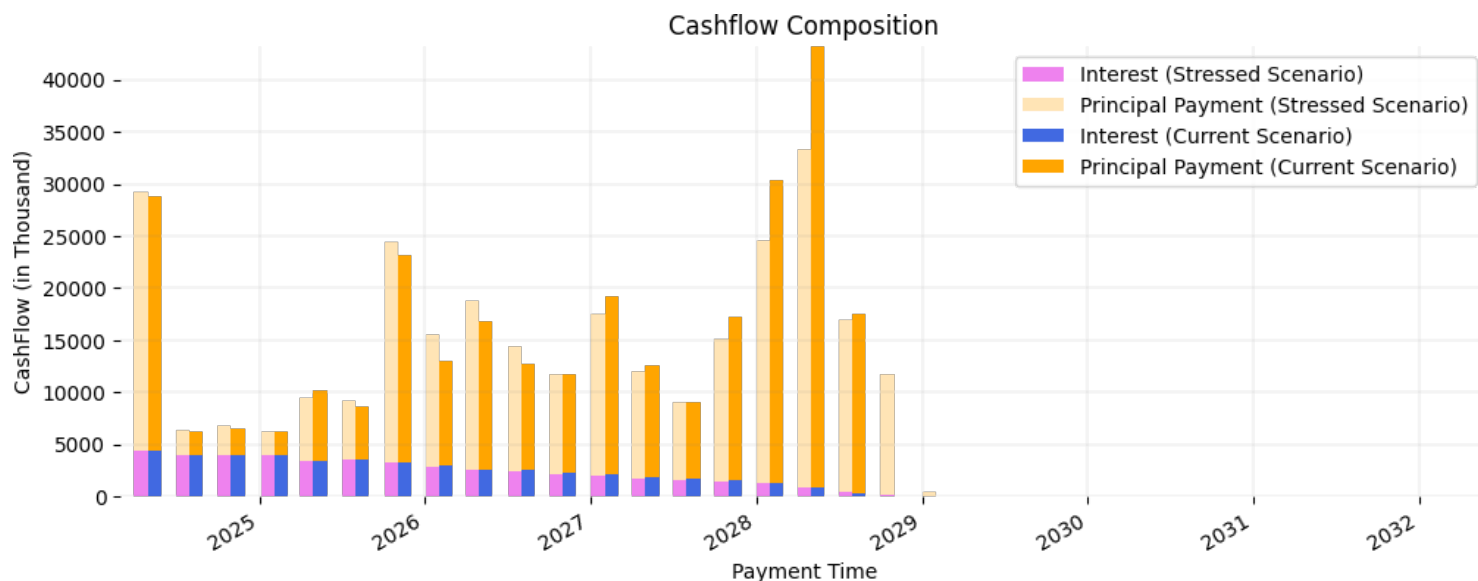
Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:

Cashflow Composition

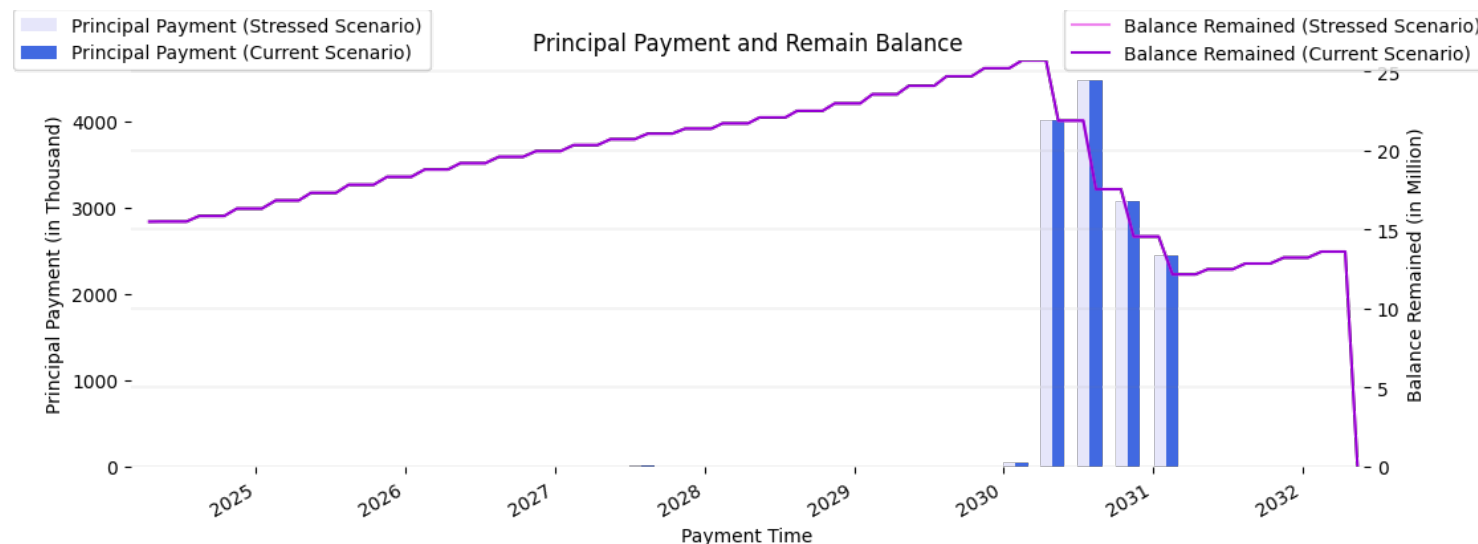
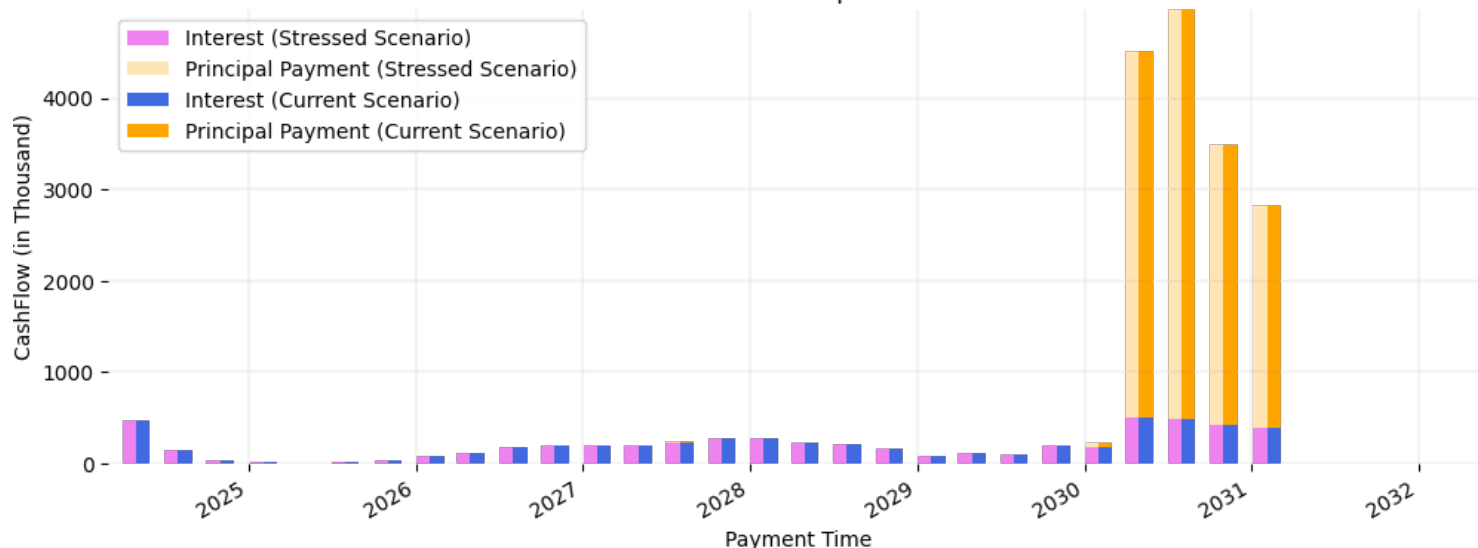

EJR's Key Rating Features & Differences Compare With Other NRSROs

2. The probabilities of default utilized are generally more conservative than industry standards.
3. Generally, our ratings are more heavily model driven and take into account fewer subjective / qualitative assumptions.
4. Generally, EJ updates the cashflow and ratings monthly based on the availability of the trustee reports.
5. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

Difference Between Implied Rating and Assigned Rating

There is no difference between model implied rating and final assigned rating.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include: 1) Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis. 2) Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate. 3) The economy and regulation policies will remain stable in the foreseeable future. Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Default Rate and Recovery Rate. According to the methodology, EJR converts the collateral assets into numbers of identical independent assets with the same default rate and recovery rate. The number of these converted assets is the Diversity Score.

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer.
