Transaction Summary

We are providing the rating of RACEP 2016-10A as a Non-NRSRO rating. The transaction closed on May 25, 2016. It had a reinvestment period, which ended on July 25, 2023. It has a maturity date of July 25, 2031. The deal was refinanced on July 25, 2018. The investments were callable as of July 25, 2020. The Dealer and Trustee were Citigroup and Wells Fargo Bank, respectively. The issued notes are collateralized by 96.96% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 3.04% second lien loans and senior unsecured loans. Bain Capital Credit serves as the collateral manager.


As of November 01, 2021, the total balance of the underlying assets was approximately \$395.79M. The diversity score of the portfolio was 73. EJR's weighted average rating score and weighted average life (years) of the collateral were 3864 and 4.86, respectively. 8.75% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 34.23%.







There are 556 assets in the underlying collateral pool, 96.96% are senior secured loans, and 3.04% with lower seniority.

Stress Analysis



In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to 35.71% and 45.22%, respectively, from its current level of 25.76%.

Estimated Loss Information


Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:





Under BB- (sf) stress level default and recovery scenario, the payment window for this tranche ranges from January, 2022 to April, 2029, by the end of the payment period (April, 2029), \$13.51M will be paid off. The remaining principal outstanding should be \$6.51M (which represents 43.4% of the tranche balance). Total interest payments of the tranche will total approximately \$3.92M.
