Transaction Summary

We are providing the rating of Regatta XIV Funding as a Non-NRSRO rating. The transaction closed on September 13, 2018. It had a reinvestment period, which ended on October 25, 2023. It has a maturity date of October 25, 2031. The Dealer and Trustee are BNP Paribas and U.S. Bank, respectively. The issued notes are collateralized by 99.6 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -98.6 second lien loans and senior unsecured loans. Napier Park Global Capital serves as the collateral manager.

As of September 04, 2022, the total balance of the underlying assets was approximately \$661.9M. The diversity score of the portfolio was 77. Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 3748.8 and 4.8, respectively. Approximately 5.2% of the portfolio's assets were rated CCC+ or less by other agencies. Senior tranche subordination was 29.92%.


Top 10 Industry Contribution






Portfolio Gross Coupon Distribution



There are 2095 non-default assets (with seniority information available) in the underlying collateral pool, 99.6% are senior secured loans, and 0.4% with lower seniority.

In EJR's view, ratings on loans may be upgraded or downgraded with little notice. In EJR's optimistic case, we assumed an notch upgrade one to the underlying assets. In EJR's stress casees, we assumed one or two notch cut to the underlying assets reflect possible market to pressure. According to EJR's Default Probability Table, the optimistic case, base case, one notch cut and two notches cut casees weighted average whole life default rate of probability are 15.8%, 32.5%, 22.9% and 39.2%, respectively.

Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:



The current principal balance of the tranche is \$448.5M. Under current default and recovery scenario, the payment window for this tranche ranges from Jul 25, 2022 to Jul 25, 2028. By the end of the payment period (Jul 25, 2028), the principal balance should be paid in full. Total interest payments of the tranche will approximately \$0.1M. Under AAA (sf) default and recovery scenario, the payment window for this tranche ranges from Jul 25, 2029, the principal balance should be paid in full. Total interest payments of the tranche ranges from Jul 25, 2022 to Oct 25, 2029. By the end of the payment period (Oct 25, 2029), the principal balance should be paid in full. Total interest payments of the tranche will approximately \$0.1M.





The number of these converted assets is the Diversity Score.
