Transaction Summary

We are providing the rating of Symphony CLO XIV as a Non-NRSRO rating. The transaction closed on May 29, 2014. It had a reinvestment period, which ended on July 14, 2018. It has a maturity date of July 14, 2026. The Dealer and Trustee are Morgan Stanley and Deutsche Bank Trust Company Americas, respectively. The issued notes are collateralized by 100.0 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -99.0 second lien loans and senior unsecured loans. Symphony Asset Management serves as the collateral manager.

As of October 03, 2022, the total balance of the underlying assets was approximately \$240.3M. The diversity score of the portfolio was 29. Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 4103.0 and 2.1, respectively. Approximately 13.8% of the portfolio's assets were rated CCC+ or less by other agencies. Senior tranche subordination was 85.8%.






Portfolio Rating Distribution





In EJR's view, ratings on loans may be upgraded or downgraded with little notice. In EJR's optimistic case, we assumed an one notch upgrade the to underlying assets. In EJR's stress casees, we assumed one or two notch cut to the underlying assets to reflect possible market pressure. According to EJR's Default Probability Table, the optimistic case, base case, one notch cut and two notches cut casees weighted average whole life default rate of probability are 10.7%, 16.4%, 31.0% and 23.2%, respectively.

Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). 


Tranche B2RR







EJR's Key Rating Features & Differences Compare With Other NRSROs

3. Generally, our ratings are more heavily model driven and take into account fewer subjective / qualitative assumptions.

4. Generally, EJR updates the cashflow and ratings monthly based on the availability of the trustee reports.

5. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

The number of these converted assets is the Diversity Score.
