Transaction Summary

We are providing the rating of VENTR 2018-31A as a Non-NRSRO rating. The transaction closed on April 04, 2018. It had a reinvestment period, which ended on April 20, 2023. It has a maturity date of April 20, 2031. The investments were callable as of April 04, 2020. The Dealer and Trustee were Natixis and U.S. Bank, respectively. The issued notes are collateralized by 98.36% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 1.64% second lien loans and senior unsecured loans. MJX Venture Management serves as the collateral manager.


As of August 01, 2021, the total balance of the underlying assets was approximately \$824.66M. The diversity score of the portfolio was 92. EJR's weighted average rating score and weighted average life (years) of the collateral were 3491 and 4.97, respectively. 9.53% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 33.30%.




The underlying assets have maturity dates from November 15, 2021 to January 31, 2029. 9.4% of the underlying assets will mature within 3 years, while another 48.3% of the underlying assets have maturities beyond 5 years.

There are 1363 assets in the underlying collateral pool, 98.36% are senior secured loans, and 1.64% with lower seniority.

Stress Analysis



In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to 30.94% and 39.41%, respectively, from its current level of 22.52%.

Estimated Loss Information


Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:


