Transaction Summary

We are providing the rating of VENTR 2019-36A as a Non-NRSRO rating. The transaction closed on April 25, 2019. It had a reinvestment period, which ended on April 20, 2024. It has a maturity date of April 20, 2032. The deal was refinanced on June 09, 2021. The investments were callable as of April 20, 2022. The Dealer and Trustee were BNP Paribas Securities Corp. and Citibank, respectively. The issued notes are collateralized by 100% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 0% second lien loans and senior unsecured loans. MJX Asset Management serves as the collateral manager.


As of July 01, 2021, the total balance of the underlying assets was approximately \$586.24M. The diversity score of the portfolio was 88. EJR's weighted average rating score and weighted average life (years) of the collateral were 3502 and 4.87, respectively. 8.0% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 35.72%.


Top 10 Industry Contribution







Stress Analysis



In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to 30.9% and 39.29%, respectively, from its current level of 22.28%.

Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). BB (sf) stress level default and recovery scenario, assuming 50% loss will happen evenly in the first year, remaining 50% will happen evenly in the next 4 years. The current principal balance of the tranche is \$33.55M. Under current default and recovery scenario, the payment window for this tranche ranges from July, 2021 to December, 2029, by the end of the payment period (December, 2029), \$35.75M will be paid off. The remaining principal outstanding should be \$1.26M (which represents 3.76% of the tranche balance). Total interest payments of the tranche will total approximately \$17.56M. Under BB (sf) stress level default and recovery scenario, the payment window for this tranche ranges from July, 2021 to December, 2029, by the end of the payment period (December, 2029), \$31.51M will be paid off. The remaining principal outstanding should be \$13.62M (which represents 4.6% of the tranche balance). Total interest payments of the tranche will total approximately \$13.62M (which represents 40.6% of the tranche balance). Total interest payments of the tranche will total approximately \$12.7M.

EJR's Key Rating Features & Differences Compare With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for a more complete description):

- 1. Our rating is derived from estimated losses.
- 2. The probabilities of default utilized are generally more conservative than industry standards.
- 3. Generally, our ratings are more heavily model driven and take into account fewer subjective / qualitative assumptions.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Default Rate and Recovery Rate. The number of these converted assets is the Diversity Score.
