Transaction Summary

We are providing the rating of Wind River 2016-2 CLO (formerly THL Credit Wind River 2016-2 CLO) as a Non-NRSRO rating. The transaction closed on November 01, 2016. It had a reinvestment period, which ended on November 01, 2023. It has a maturity date of November 01, 2031. The Dealer and Trustee are Morgan Stanley and U.S. Bank, respectively. The issued notes are collateralized by 99.5 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -98.5 second lien loans and senior unsecured loans. First Eagle Alternative Credit serves as the collateral manager.

As of November 27, 2023, the total balance of the underlying assets was approximately \$635.1M. The diversity score of the portfolio was 69. Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 3753.5 and 4.2, respectively. Approximately 8.4% of the portfolio's assets were rated CCC+ or less by other agencies. Senior tranche subordination was 31.36%.


Top 10 Industry Contribution



Gross Coupon of Underlying Assets





There are 872 non-default assets (with seniority information available) in the underlying collateral pool, 99.5% are senior secured loans, and 0.5% with lower seniority.

Sensitivity Analysis



In EJR's view, ratings on loans may be upgraded or downgraded with little notice. In EJR's optimistic case, we assumed an notch one upgrade to the underlying assets. In EJR's stress cases, we assumed one or two notch cut to the underlying assets reflect possible market to pressure. According to EJR's Default Probability Table, the optimistic case, base case, one notch cut and two notches cut cases weighted average whole life default rate of probability are 14.3%, 30.2%, 21.4% and 37.8%, respectively.

Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). 





The charts reflects the remaining balance and cashflow forcasting under a) current default and recovery scenario and b) BB- (sf) stress level default and recovery scenario, assuming 50% loss will happen evenly in the first 2 years. The current principal balance of the tranche is \$35.1M. Under current default and recovery scenario, the payment window for this tranche ranges from Nov 01, 2023 to May 01, 2031. By the end of the payment period (May 01, 2031), the principal balance should be paid in full. Total interest payments of the tranche will approximately \$0.0M. Under BB- (sf) default and recovery scenario, the payment window for this tranche ranges from Nov 01, 2023 to May 01, 2031). By the end of the payment period (May 01, 2031) and recovery scenario, the payment window for this tranche ranges from Nov 01, 2023 to May 01, 2031. By the end of the payment period (May 01, 2031), the principal balance should be paid in full. Total interest payments of the tranche vill approximately \$0.0M.



EJR's Key Rating Features & Differences Compare With Other NRSROs
