# **Transaction Summary**

We are providing the rating of WINDR 2019-2A as a Non-NRSRO rating. The transaction closed on November 05, 2019. It had a reinvestment period, which ended on November 05, 2024. It has a maturity date of January 15, 2033. The investments were callable as of November 05, 2021. The Dealer and Trustee were Morgan Stanley and Wells Fargo Bank, respectively. The issued notes are collateralized by 96.09% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 3.91% second lien loans and senior unsecured loans. First Eagle Alternative Credit serves as the collateral manager.

As of August 01, 2021, the total balance of the underlying assets was approximately \$516.08M. The diversity score of the portfolio was 61. EJR's weighted average rating score and weighted average life (years) of the collateral were 3781 and 5.05, respectively. 5.24% of the portfolio's assets were rated CCC+ or less by other NRSROs. Senior tranche subordination was 34.57%.

There are 376 assets in the underlying collateral pool, 96.09% are senior secured loans, and 3.91% with lower seniority.

## **Stress Analysis**



In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to 35.7% and 45.69%, respectively, from its current level of 25.65%.

## **Estimated Loss Information**


Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:



The remaining principal outstanding should be \$0.02M (which represents 0.07% of the tranche balance). Total interest payments of the tranche will total approximately \$11.34M. Under BB+ (sf) stress level default and recovery scenario, the payment window for this tranche ranges from October, 2021 to January, 2030, by the end of the payment period (January, 2030), \$26.7M will be paid off. The remaining principal outstanding should be \$3.3M (which represents 11.0% of the tranche balance). Total interest payments of the tranche will total approximately \$11.74M.

The charts reflects the remaining balance and cashflow forcasting under a).current default and recovery scenario and b). BB- (sf) stress level default and recovery scenario, assuming 50% loss will happen evenly in the first year, remaining 50% will happen evenly in the next 4 years. The current principal balance of the tranche is \$20.0M. Under current default and recovery scenario, the payment window for this tranche ranges from October, 2021 to July, 2030, by the end of the payment period (July, 2030), \$17.35M will be paid off. The remaining principal outstanding should be \$2.65M (which represents 13.25% of the tranche balance). Total interest payments of the tranche will total approximately \$14.5M. Under BB- (sf) stress level default and recovery scenario, the payment window for this tranche ranges from October, 2021 to July, 2030, by the end of the payment period (July, 2030), \$11.99M will be paid off. The remaining principal outstanding should be \$8.01M (which represents 40.05% of the tranche balance). Total interest payments of the tranche will total approximately \$13.72M.

The number of these converted assets is the Diversity Score.
