## **Transaction Summary**

The transaction closed on Jun 19 2018 and matures in Jun 2021. The pool's current aggregate principal balance is \$635.0 million compared to \$635.0 million at close.

The single asset of the pool is secured by JQH Hotel Portfolio which comprised of 24 properties. Occupancy at the subject was 68%.



The weighted average coupon (WAC) and the weighted average age (WALA) were 2.43% and 30 months as of 12/15/2020, respectively. There are a total of 1 loans and 24 properties in the portfolio. The appraisal LTV was approximately 63.2% compared to the Original loan to value (LTV), which was approximately 63.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.68x. As of 12/15/2020, 200.00% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 68%.





Among assets in the portfolio, there are 3 properties (22% of total balance) located in Texas, 3 properties (16% of total balance) in % of Total Portfolio 100 Arkansas, 5 properties (12% of total balance) in Missouri, 3 properties (11% of total balance) in Nebraska, 1 property (7% of total balance) in Tennessee, 2 properties (6% of total balance) in Oklahoma, 1 property (6% of total balance) in Colorado, 1 property (5% of total balance) in New Mexico, 2 properties (4% of total balance) in Illinois and 1 property (4% of total balance) in Virginia. Other properties are located in the state of Illinois, Virginia, South Carolina and South Dakota.

Among all the assets in the portfolio, 100% of total balance had LTVs between 60% and 70%.









## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
