Transaction Summary

The transaction closed on Feb 16 2017 and matures in Feb 2027. The pool's current aggregate principal balance is \$958.1 million compared to \$977.8 million at close.

The largest loan of the pool (7.7%) is secured by The Summit Birmingham located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Belk's (24.00%) and RSM US LLP (5.24%). The second largest loan of the pool (7.3%) is secured by KOMO Plaza located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 82%. The major tenants included Sinclair Broadcasting (41.55%) and TierPoint Seattle Ho (11.31%). The third largest loan of the pool (5.9%) is secured by JW Marriott Desert Springs located in metropolitan area. Occupancy at the subject was 59%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.55% and 46 months as of 10/15/2020, respectively. There are a total of 63 loans and 94 properties in the portfolio. The appraisal LTV was approximately 56.9% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.25x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration








Local Distribution





Net Cash Flow DSCR (x)





DSCRs ranged from 0.5x to 4.5x. There are 1 assets (1.0% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (5.2% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (24.7% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (30.9% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (20.1% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (20.1% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (5.2% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (5.2% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (2.2% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
