## Transaction Summary

The transaction closed on Jun 07 2016 and matures in Apr 2046. The pool's current aggregate principal balance is \$613.4 million compared to \$658.4 million at close.

The largest loan of the pool (9.5%) is secured by Hyatt Regency Huntington Beach Resort & Spa located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 61%. The second largest loan of the pool (8.9%) is secured by Belk Headquarters located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Belk's (100.00%). The third largest loan of the pool (7.0%) is secured by 525 Seventh Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 81%. The major tenants included Kobra International Ltd. (5.33%) and Cameron Industries Inc. (4.82%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.86% and 72 months as of 03/15/2022, respectively. There are a total of 44 loans and 52 properties in the portfolio. The appraisal LTV was approximately 56.8% compared to the Original loan to value (LTV), which was approximately 59.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.65x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.

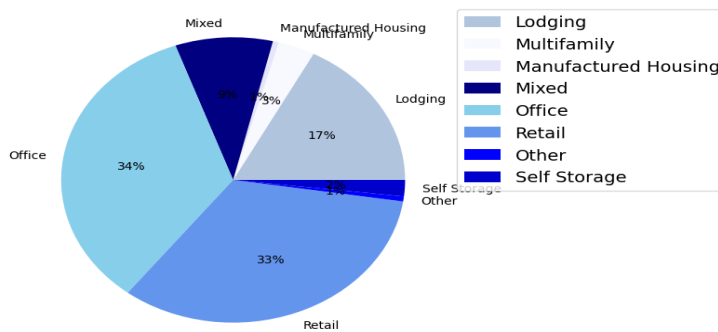

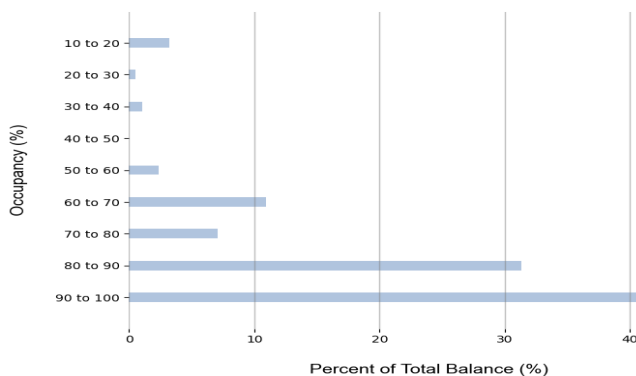

### Occupancy Distribution (%)

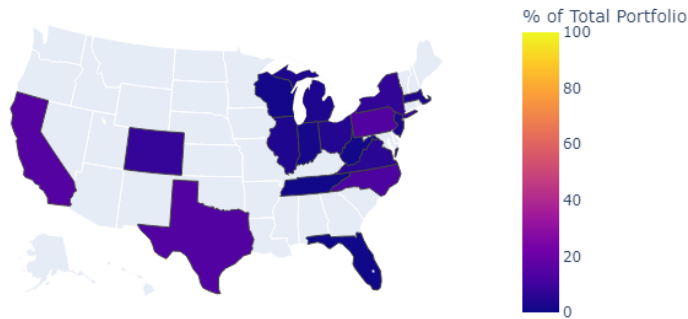

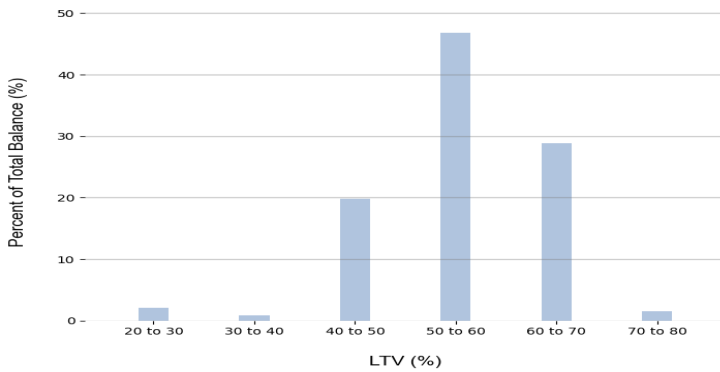
Local Distribution

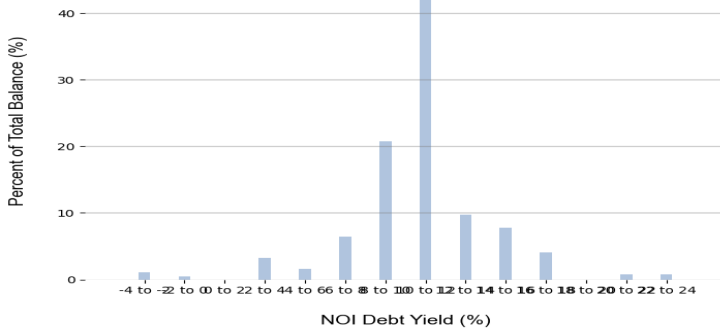

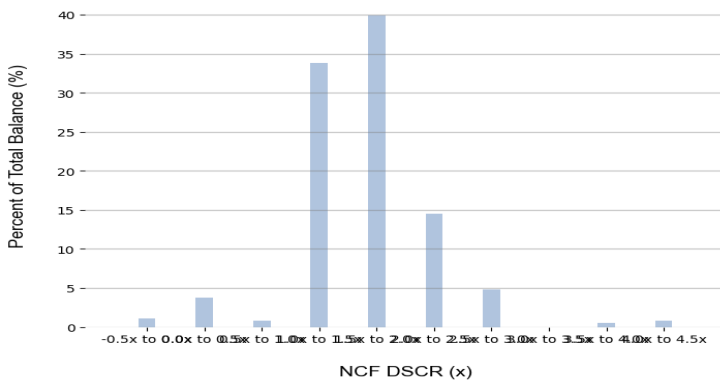
NOI Debt Yield (%)

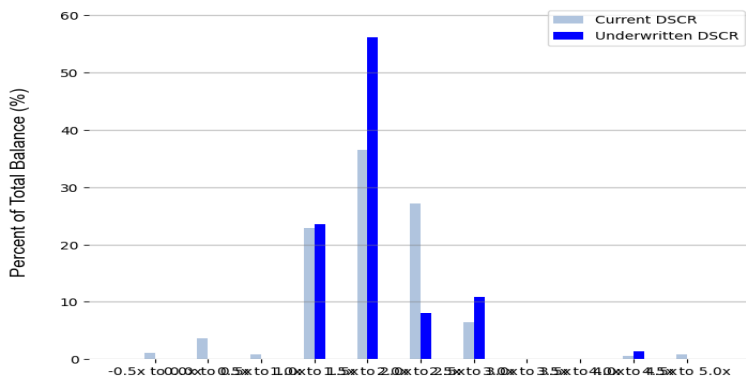

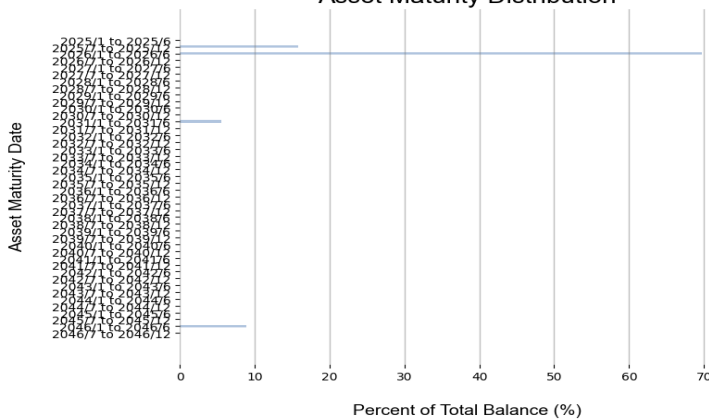
DSCR Distribution (x)



DSCRs ranged from -0.5x to 5.0x. There are 1 assets (1.1% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (3.7% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.9% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (22.8% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (36.6% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (27.2% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (6.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.8% of total balance) with DSCR between 4.5x and 5.0x. There are 7 assets (96.9% of total balance) that have maturity dates between 2025/7 and 2025/12, 34 assets (427.5% of total balance) that have maturity dates between 2026/1 and 2026/6, 2 assets (34.3% of total balance) that have maturity dates between 2031/1 and 2031/6 and 1 assets (54.7% of total balance) that have maturity dates between 2046/1 and 2046/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:
