Transaction Summary

The transaction closed on Feb 27 2020 and matures in Jan 2027. The pool's current aggregate principal balance is \$229.0 million compared to \$229.0 million at close.

The single asset of the pool is secured by Bravern Office Commons - Trust located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 100%. The major tenants included Microsoft Corporation (34.04%) and Microsoft Corporation (33.31%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.20% and 26 months as of 03/15/2022, respectively. There are a total of 1 loans and 1 properties in the portfolio. The appraisal LTV was approximately 50.2% compared to the Original loan to value (LTV), which was approximately 50.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.30x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 100%.






Occupancy Distribution (%)



Among all the assets in the portfolio, 100% of total balance had LTVs between 50% and 60%.









EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
