Transaction Summary

The transaction closed on Feb 27 2017 and matures in Nov 2031. The pool's current aggregate principal balance is \$839.7 million compared to \$856.1 million at close.

The largest loan of the pool (7.3%) is secured by Alhambra Towers located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 92%. The major tenants included AerSale Inc (15.73%) and Becker & Poliakoff P.A. (12.93%). The second largest loan of the pool (6.7%) is secured by 1166 Avenue of the Americas located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included DE Shaw & Co (43.36%) and Arcesium (20.00%). The third largest loan of the pool (6.7%) is secured by 1000 Denny Way located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 93%. The major tenants included Seattle Times Company (59.41%) and Level 3 Communications (18.65%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.02% and 45 months as of 10/15/2020, respectively. There are a total of 58 loans and 75 properties in the portfolio. The appraisal LTV was approximately 60.2% compared to the Original loan to value (LTV), which was approximately 59.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





Occupancy Distribution (%)




Local Distribution





There were 4 assets (3.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (22.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 24 assets (47.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (19.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.2% of total balance) with NCF DSCR between 2.5x and 3.0x and 2 assets (5.7% of total balance) with NCF DSCR between 3.0x and 3.5x. 



There are 13 assets (11.7% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (37.0% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (39.0% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (5.2% of total balance) with DSCR between 2.5x and 3.0x and 3 assets (7.1% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 2.0x.

There are 2 assets (2.1% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (0.8% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (4.9% of total balance) that have maturity dates between 2025/1 and 2025/6, 19 assets (23.9% of total balance) that have maturity dates between 2026/7 and 2026/12, 34 assets (65.3% of total balance) that have maturity dates between 2027/1 and 2027/6 and 1 assets (3.0% of total balance) that have maturity dates between 2031/7 and 2031/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
