Transaction Summary

The transaction closed on Jun 11 2019 and matures in May 2029. The pool's current aggregate principal balance is \$934.2 million compared to \$937.0 million at close.

The largest loan of the pool (6.1%) is secured by SSTII Self Storage Portfolio II located in Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-15.36% metropolitan area. Occupancy at the subject was 89%. The second largest loan of the pool (5.9%) is secured by Vanguard Portfolio - Trust located in Montgomery County-Bucks County-Chester County, PA metropolitan area. Occupancy at the subject was 100%. The largest tenant was The Vanguard Group (100.00%). The third largest loan of the pool (5.2%) is secured by GNL Industrial Portfolio located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Rubbermaid Incorporated (27.37%) and Wolverine World Wide Inc. (19.18%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.80% and 19 months as of 10/15/2020, respectively. There are a total of 50 loans and 517 properties in the portfolio. The appraisal LTV was approximately 60.7% compared to the Original loan to value (LTV), which was approximately 60.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.91x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)







Among assets in the portfolio, there are 8 properties (14% of total balance) located in Pennsylvania, 12 properties (11% of total balance) in California, 54 properties (9% of total balance) in Florida, 17 properties (7% of total balance) in Ohio, 27 properties (7% of total balance) in Texas, 6 properties (6% of total balance) in North Carolina, 3 properties (6% of total balance) in New York and 4 properties (4% of total balance) in Minnesota. Other properties are located in the state of Michigan, Louisiana, Wisconsin, Massachusetts, Colorado, Washington DC, Maryland, Oregon, Alabama, Tennessee, Illinois, Mississippi, Nevada, Indiana, Virginia, Hawaii, Delaware, South Carolina, Georgia, New Mexico, Washington, Connecticut, Idaho, Iowa, Missouri, Nebraska, Kansas, Oklahoma, Kentucky, Arizona, Arkansas and New Hampshire.

Among all the assets in the portfolio, 1 assets (3% of total balance) had LTVs between 20% and 30%, 3 assets (8% of total balance) with LTVs between 30% and 40%, 1 assets (1% of total balance) with LTVs between 40% and 50%, 9 assets (25% of total balance) with LTVs between 50% and 60%, 28 assets (50% of total balance) with LTVs between 60% and 70% and 8 assets (12% of total balance) with LTVs between 70% and 80%.





Most recent net operating income debt yield ranged from 4% to 29% with a weighted average NOI debt yield of 10.7%. NOI debt yield ranged from 4% to 29%. There were 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 5 assets (8% of total balance) with NOI debt yield between 6% and 8%, 16 assets (35% of total balance) with NOI debt yield between 8% and 10%, 13 assets (38% of total balance) with NOI debt yield between 10% and 12%, 7 assets (6% of total balance) with NOI debt yield between 12% and 14%, 2 assets (2% of total balance) with NOI debt yield between 14% and 16%, 3 assets (4% of total balance) with NOI debt yield between 16% and 18%, 2 assets (4% of total balance) with NOI debt yield between 18% and 20%, 1 assets (0% of total balance) with NOI debt yield between 28% and 30%

NCF DSCR ranged from 0.0x to 3.0x. There were 2 assets (5.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 6 assets (5.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 25 assets (51.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 15 assets (33.4% of total balance) with NCF DSCR between 2.0x and 2.5x and 2 assets (4.3% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.9x.







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
