Transaction Summary

The transaction closed on Jun 11 2019 and matures in May 2029. The pool's current aggregate principal balance is \$933.9 million compared to \$937.0 million at close.

The largest loan of the pool (6.1%) is secured by SSTII Self Storage Portfolio II located in Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-15.36% metropolitan area. Occupancy at the subject was 89%. The second largest loan of the pool (5.9%) is secured by Vanguard Portfolio - Trust located in Montgomery County-Bucks County-Chester County, PA metropolitan area. Occupancy at the subject was 100%. The largest tenant was The Vanguard Group (100.00%). The third largest loan of the pool (5.2%) is secured by GNL Industrial Portfolio located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Rubbermaid Incorporated (27.37%) and Wolverine World Wide Inc. (19.18%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.80% and 21 months as of 12/15/2020, respectively. There are a total of 50 loans and 517 properties in the portfolio. The appraisal LTV was approximately 60.7% compared to the Original loan to value (LTV), which was approximately 60.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.91x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

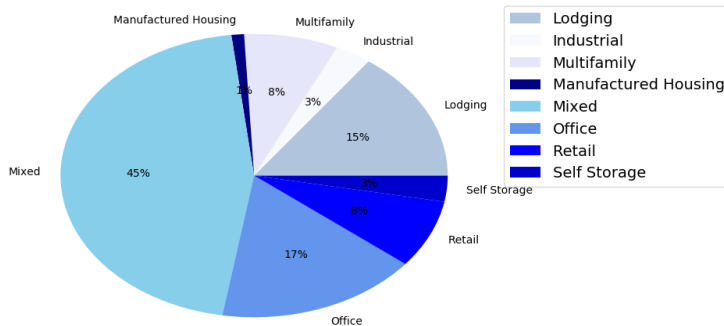

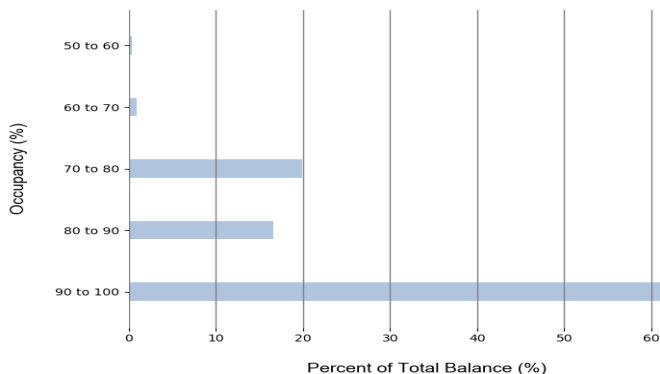

Occupancy Distribution (%)

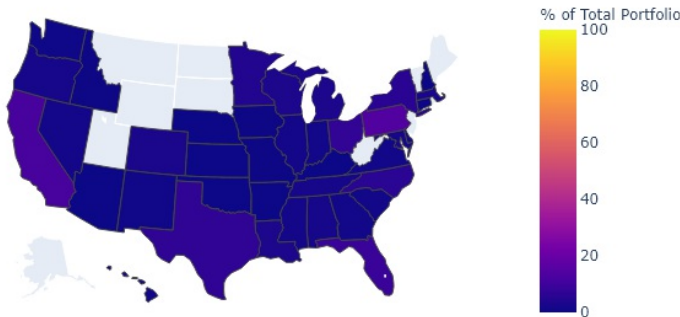

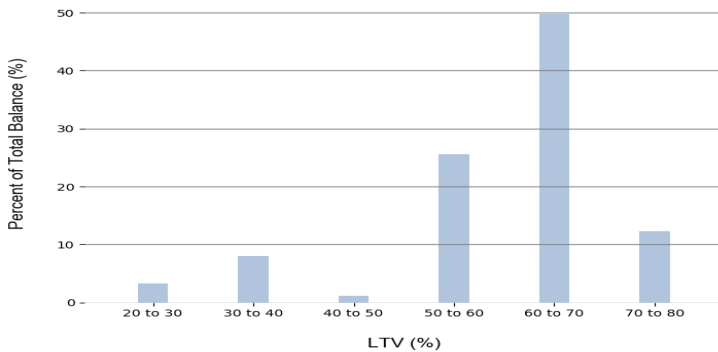
Local Distribution

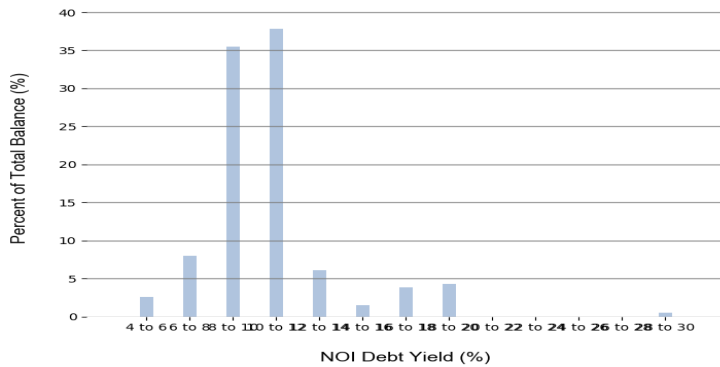

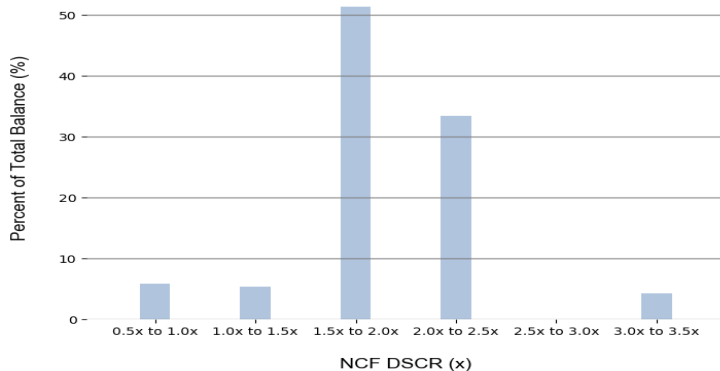
NOI Debt Yield (%)

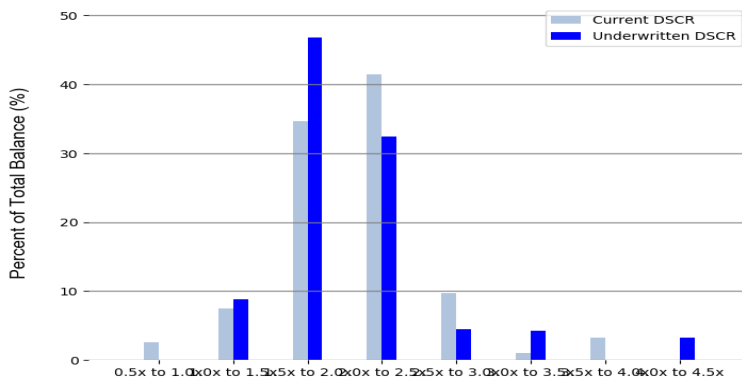

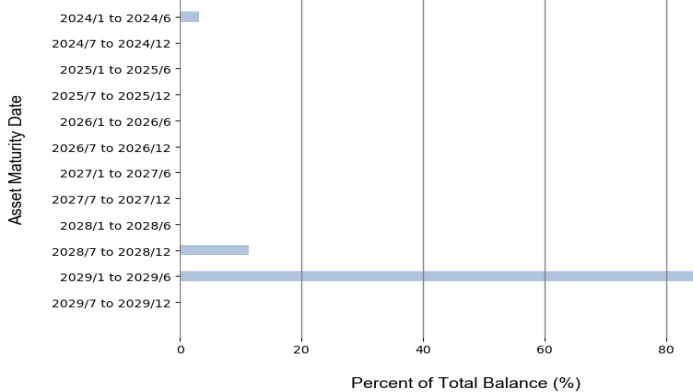
DSCR Distribution (x)

There are 1 assets (2.6% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (7.5% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (34.6% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (41.4% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (9.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (3.2% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
