Transaction Summary

The transaction closed on Feb 19 2020 and matures in Sep 2033. The pool's current aggregate principal balance is \$1015.4 million compared to \$1016.8 million at close.

The largest loan of the pool (6.4%) is secured by Parkmerced - Pooled located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 94%. The second largest loan of the pool (5.9%) is secured by 650 Madison Avenue - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Ralph Lauren Corporation (46.14%) and Memorial Sloan Kettering Cancer Center (16.77%). The third largest loan of the pool (5.9%) is secured by Kings Plaza located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Lowe's Home Improvement (14.04%) and Primark (12.66%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.63% and 11 months as of 12/15/2020, respectively. There are a total of 46 loans and 121 properties in the portfolio. The appraisal LTV was approximately 57.3% compared to the Original loan to value (LTV), which was approximately 57.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.46x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 95%.



Type Concentration







Most recent net operating income debt yield ranged from 2% to 29% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 2% to 29%. There were 1 assets (1% of total balance) with NOI debt yield between 2% and 4%, 3 assets (2% of total balance) with NOI debt yield between 4% and 6%, 10 assets (15% of total balance) with NOI debt yield between 6% and 8%, 14 assets (51% of total balance) with NOI debt yield between 8% and 10%, 7 assets (10% of total balance) with NOI debt yield between 10% and 12%, 7 assets (15% of total balance) with NOI debt yield between 12% and 14%, 2 assets (1% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (4% of total balance) with NOI debt yield between 28% and 30%





There are 43 assets (92.6% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.7% of total balance) with DSCR between 0.5x and 1.0x, 1 assets (0.8% of total balance) with DSCR between 1.5x and 2.0x and 1 assets (5.9% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.5x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
