Transaction Summary

The transaction closed on Feb 19 2020 and matures in Sep 2033. The pool's current aggregate principal balance is \$1012.2 million compared to \$1016.8 million at close.

The largest loan of the pool (6.4%) is secured by Parkmerced - Pooled located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 76%. The second largest loan of the pool (5.9%) is secured by 650 Madison Avenue - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Ralph Lauren Corporation (46.14%) and Memorial Sloan Kettering Cancer Center (16.77%). The third largest loan of the pool (5.9%) is secured by Kings Plaza located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 91%. The major tenants included M.A.C Cosmetics (41.76%) and Lovisa (14.04%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.62% and 26 months as of 03/15/2022, respectively. There are a total of 46 loans and 118 properties in the portfolio. The appraisal LTV was approximately 57.0% compared to the Original loan to value (LTV), which was approximately 57.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.36x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.



Type Concentration







Among assets in the portfolio, there are 11 properties (19% of total balance) located in New York, 2 properties (16% of total balance) in Washington, 4 properties (13% of total balance) in California, 2 properties (5% of total balance) in New Jersey, 19 properties (5% of total balance) in Georgia, 2 properties (5% of total balance) in North Carolina and 4 properties (4% of total balance) in Pennsylvania. Other properties are located in the state of Illinois, Oregon, Florida, Missouri, Tennessee, Arizona, Minnesota, Indiana, Maryland, Michigan, Ohio, Oklahoma, Louisiana, Virginia, Mississippi, South Dakota, Idaho, Massachusetts, Alabama, South Carolina, Kansas, Nebraska, New Hampshire and Texas.

Among all the assets in the portfolio, 1 assets (6% of total balance) had LTVs between 20% and 30%, 3 assets (12% of total balance) with LTVs between 30% and 40%, 1 assets (6% of total balance) with LTVs between 40% and 50%, 8 assets (15% of total balance) with LTVs between 50% and 60%, 29 assets (54% of total balance) with LTVs between 60% and 70% and 4 assets (7% of total balance) with LTVs between 70% and 80%.








Most recent net operating income debt yield ranged from 0% to 17% with a weighted average NOI debt yield of 9.3%. NOI debt yield ranged from 0% to 17%. There were 1 assets (1% of total balance) with NOI debt yield between 0% and 2%, 2 assets (2% of total balance) with NOI debt yield between 2% and 4%, 5 assets (6% of total balance) with NOI debt yield between 4% and 6%, 7 assets (10% of total balance) with NOI debt yield between 6% and 8%, 15 assets (53% of total balance) with NOI debt yield between 8% and 10%, 7 assets (10% of total balance) with NOI debt yield between 10% and 12%, 7 assets (13% of total balance) with NOI debt yield between 12% and 14%, 1 assets (4% of total balance) with NOI debt yield between 14% and 16% and 1 assets (1% of total balance) with NOI debt yield between 16% and 18%.

There were 1 assets (1.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (3.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 8 assets (8.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 8 assets (6.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 17 assets (54.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (11.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.5% of total balance) with NCF DSCR between 3.0x and 3.5x, 3 assets (9.9% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (4.3% of total balance) with NCF DSCR between 4.0x and 4.5x. 



DSCRs ranged from 0.0x to 4.5x.There are 1 assets (1.3% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (3.2% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (5.0% of total balance) with DSCR between 1.0x and 1.5x, 8 assets (7.0% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (48.3% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (20.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.5% of total balance) with DSCR between 3.0x and 3.5x, 3 assets (9.9% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (4.3% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.5x.

There are 2 assets (67.9% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (22.7% of total balance) that have maturity dates between 2025/1 and 2025/6, 18 assets (372.7% of total balance) that have maturity dates between 2029/7 and 2029/12, 22 assets (359.8% of total balance) that have maturity dates between 2030/1 and 2030/6, 1 assets (26.5% of total balance) that have maturity dates between 2031/1 and 2031/6 and 2 assets (162.6% of total balance) that have maturity dates between 2031/1 and 2031/6 and 2 assets (162.6% of total balance) that have maturity dates between 2033/7 and 2033/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
