Transaction Summary

The transaction closed on Jun 25 2020 and matures in Sep 2034. The pool's current aggregate principal balance is \$807.2 million compared to \$808.4 million at close.

The largest loan of the pool (7.4%) is secured by Parkmerced - Trust located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 94%. The second largest loan of the pool (7.4%) is secured by 525 Market Street - Trust located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 97%. The major tenants included Amazon.com Services LLC (39.51%) and Sephora USA, Inc. (16.18%). The third largest loan of the pool (6.2%) is secured by The Cove at Tiburon - Trust located in San Rafael, CA metropolitan area. Occupancy at the subject was 94%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.62% and 8 months as of 10/15/2020, respectively. There are a total of 49 loans and 153 properties in the portfolio. The appraisal LTV was approximately 53.3% compared to the Original loan to value (LTV), which was approximately 53.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.02x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.






Local Distribution









EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
