Transaction Summary

The transaction closed on Jun 25 2020 and matures in Sep 2034. The pool's current aggregate principal balance is \$804.0 million compared to \$808.4 million at close.

The largest loan of the pool (7.5%) is secured by Parkmerced - Trust located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 76%. The second largest loan of the pool (7.5%) is secured by 525 Market Street - Trust located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 91%. The major tenants included Amazon.com Services LLC (39.51%) and Sephora USA, Inc. (16.18%). The third largest loan of the pool (6.2%) is secured by The Cove at Tiburon - Trust located in San Rafael, CA metropolitan area. Occupancy at the subject was 89%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.62% and 26 months as of 04/15/2022, respectively. There are a total of 49 loans and 153 properties in the portfolio. The appraisal LTV was approximately 53.0% compared to the Original loan to value (LTV), which was approximately 53.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.51x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.

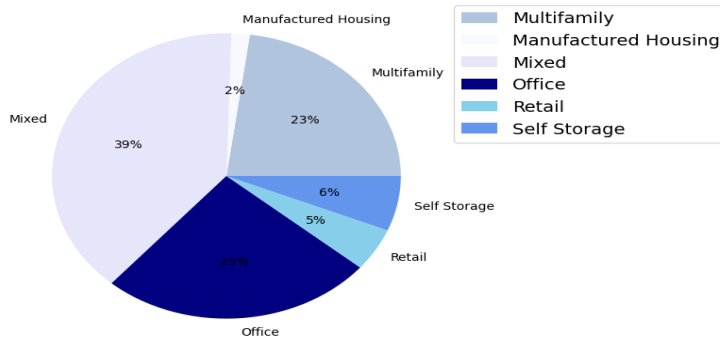

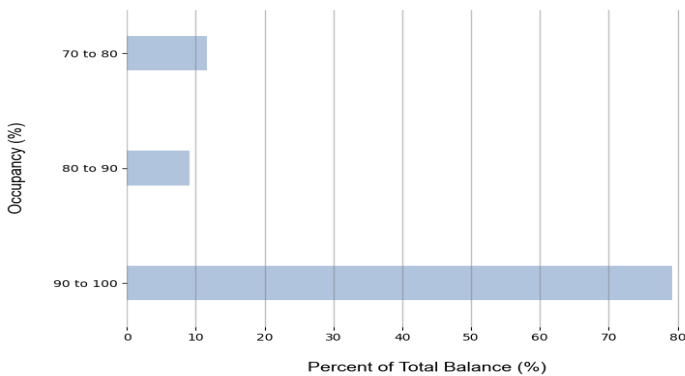

Occupancy Distribution (%)

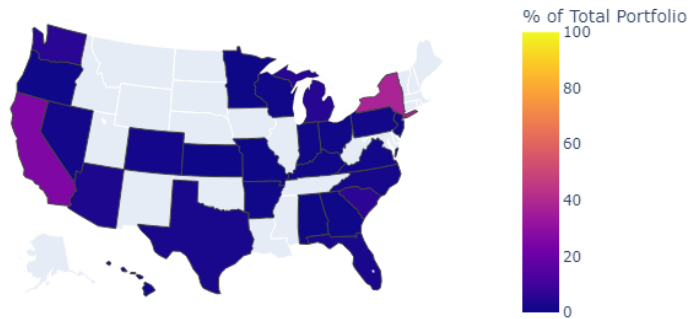

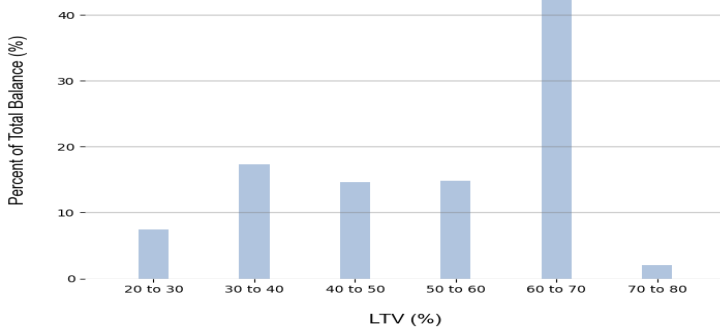
Local Distribution

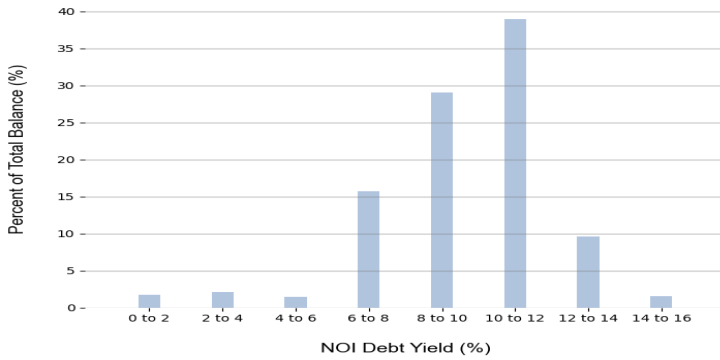

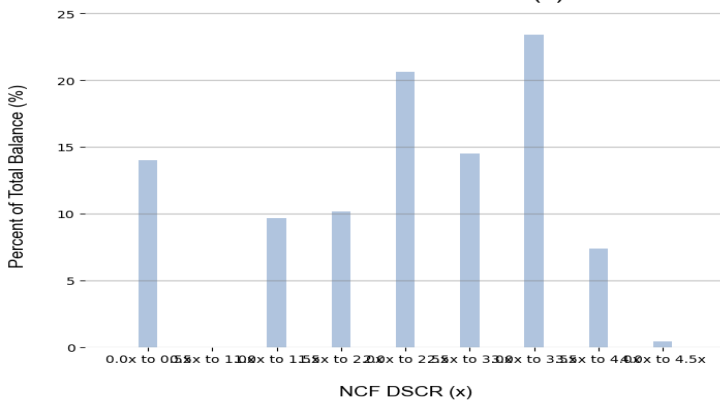
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

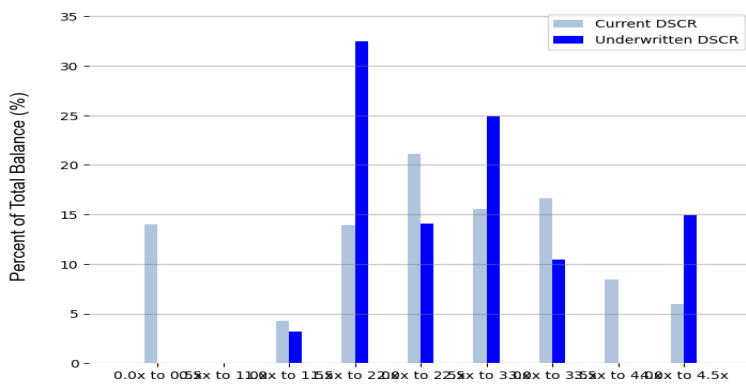

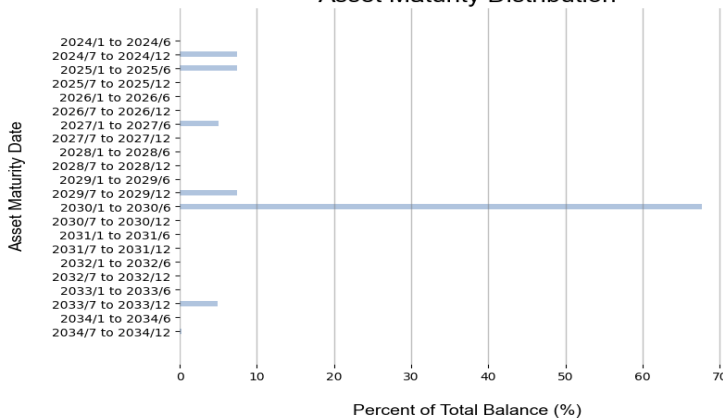
DSCR Distribution (x)

There are 6 assets (14.0% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (4.3% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (13.9% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (21.1% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (15.6% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (16.7% of total balance) with DSCR between 3.0x and 3.5x, 5 assets (8.5% of total balance) with DSCR between 3.5x and 4.0x and 2 assets (6.0% of total balance) with DSCR between 4.0x and 4.5x. There are 1 assets (60.0% of total balance) that have maturity dates between 2024/7 and 2024/12, 3 assets (59.4% of total balance) that have maturity dates between 2025/1 and 2025/6, 1 assets (40.0% of total balance) that have maturity dates between 2027/1 and 2027/6, 3 assets (59.2% of total balance) that have maturity dates between 2029/7 and 2029/12, 38 assets (544.0% of total balance) that have maturity dates between 2030/1 and 2030/6, 1 assets (39.5% of total balance) that have maturity dates between 2033/7 and 2033/12 and 2 assets (1.8% of total balance) that have maturity dates between 2034/7 and 2034/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
