Transaction Summary

The transaction closed on Mar 24 2020 and matures in Mar 2030. The pool's current aggregate principal balance is \$943.1 million compared to \$943.4 million at close.

The largest loan of the pool (9.0%) is secured by Murphy Crossing located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Renesas (59.46%) and Elo Touch Solutions (20.58%). The second largest loan of the pool (8.4%) is secured by Moffett Towers Buildings A, B & C - Trust located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Google (85.71%) and Comcast (11.74%). The third largest loan of the pool (5.3%) is secured by 1633 Broadway - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Allianz Asset Management of America L.P. (12.53%) and WMG Acquisition Corp (11.47%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.68% and 8 months as of 10/15/2020, respectively. There are a total of 35 loans and 160 properties in the portfolio. The appraisal LTV was approximately 51.9% compared to the Original loan to value (LTV), which was approximately 52.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.56x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.





Occupancy Distribution (%)




Local Distribution



Most recent net operating income debt yield ranged from 4% to 35% with a weighted average NOI debt yield of 12.0%. NOI debt yield ranged from 4% to 35%. There were 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 9 assets (12% of total balance) with NOI debt yield between 6% and 8%, 9 assets (37% of total balance) with NOI debt yield between 8% and 10%, 4 assets (10% of total balance) with NOI debt yield between 10% and 12%, 8 assets (24% of total balance) with NOI debt yield between 12% and 14%, 1 assets (5% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (5% of total balance) with NOI debt yield between 24% and 26%, 1 assets (4% of total balance) with NOI debt yield between 34% and 36%

There were 30 assets (86.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (2.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 1 assets (1.3% of total balance) with NCF DSCR between 2.0x and 2.5x and 3 assets (9.6% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 2.6x.







DSCRs ranged from 0.0x to 3.0x. There are 31 assets (91.9% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.5% of total balance) with DSCR between 1.5x and 2.0x, 1 assets (1.3% of total balance) with DSCR between 2.0x and 2.5x and 2 assets (4.3% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.5x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
