## **Transaction Summary**

The transaction closed on Mar 24 2020 and matures in Mar 2030. The pool's current aggregate principal balance is \$941.8 million compared to \$943.4 million at close.

The largest loan of the pool (9.0%) is secured by Murphy Crossing located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Intersil Corporation (42.54%) and Elo Touch Solutions Inc (20.58%). The second largest loan of the pool (8.4%) is secured by Moffett Towers Buildings A, B & C - Trust located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Google (85.71%) and Comcast (11.74%). The third largest loan of the pool (5.3%) is secured by 1633 Broadway - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Allianz Asset Management of America L.P. (12.53%) and WMG Acquisition Corp (11.47%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.68% and 26 months as of 04/15/2022, respectively. There are a total of 35 loans and 147 properties in the portfolio. The appraisal LTV was approximately 52.8% compared to the Original loan to value (LTV), which was approximately 51.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.20x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.



Type Concentration











There were 2 assets (6.1% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (6.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 8 assets (14.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 6 assets (11.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (26.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (15.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (5.3% of total balance) with NCF DSCR between 3.0x and 3.5x, 2 assets (8.5% of total balance) with NCF DSCR between 3.5x and 4.0x and 2 assets (6.9% of total balance) with NCF DSCR between 4.0x and 4.5x. 



DSCRs ranged from 0.0x to 5.0x.There are 2 assets (6.1% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (6.1% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (14.0% of total balance) with DSCR between 1.0x and 1.5x, 6 assets (9.2% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (27.8% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (7.1% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (14.3% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (5.3% of total balance) with DSCR between 3.5x and 4.0x, 2 assets (5.8% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (4.2% of total balance) with DSCR between 4.5x and 5.0x. There are 6 assets (193.9% of total balance) that have maturity dates between 2025/1 and 2025/6, 5 assets (184.9% of total balance) that have maturity dates between 2029/7 and 2029/12 and 24 assets (562.9% of total balance) that have maturity dates between 2030/1 and 2030/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
