Transaction Summary

The transaction closed on Jul 31 2020 and matures in Jul 2034. The pool's current aggregate principal balance is \$1106.3 million compared to \$1106.5 million at close.

The largest loan of the pool (6.8%) is secured by Agellan Portfolio - Pooled located in Fort Worth-Arlington, TX-4.79% Elgin, IL-3.45% metropolitan area. Occupancy at the subject was 90%. The major tenants included United Natural Foods, Inc. (7.60%) and General Motors (6.56%). The second largest loan of the pool (15.5%) is secured by Agellan Portfolio - Non-Pooled located in Fort Worth-Arlington, TX-4.79% Elgin, IL-3.45% metropolitan area. Occupancy at the subject was 90%. The major tenants included United Natural Foods, Inc. (7.60%) and General Motors (6.56%). The third largest loan of the pool (6.8%) is secured by Moffett Towers Buildings A, B & C - Pooled located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Google (85.70%) and Comcast (11.74%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.87% and 5 months as of 10/15/2020, respectively. There are a total of 38 loans and 200 properties in the portfolio. The appraisal LTV was approximately 54.3% compared to the Original loan to value (LTV), which was approximately 54.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.87x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 2% to 31% with a weighted average NOI debt yield of 13.0%. NOI debt yield ranged from 2% to 31%. 



DSCRs ranged from 0.0x to 3.0x. There are 37 assets (98.7% of total balance) with DSCR between 0.0x and 0.5x and 1 assets (1.3% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.9x.

There are 4 assets (8.6% of total balance) that have maturity dates between 2025/1 and 2025/6, 2 assets (22.3% of total balance) that have maturity dates between 2025/7 and 2025/12, 1 assets (6.3% of total balance) that have maturity dates between 2026/7 and 2026/12, 2 assets (7.6% of total balance) that have maturity dates between 2029/7 and 2029/12, 6 assets (17.1% of total balance) that have maturity dates between 2030/1 and 2030/6, 21 assets (25.4% of total balance) that have maturity dates between 2030/7 and 2030/12, 1 assets (5.9% of total balance) that have maturity dates between 2032/1 and 2032/6 and 1 assets (6.8% of total balance) that have maturity dates between 2034/7 and 2034/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
