Transaction Summary

The transaction closed on Sep 30 2020 and matures in Mar 2032. The pool's current aggregate principal balance is \$1110.2 million compared to \$1111.0 million at close.

The largest loan of the pool (7.7%) is secured by BX Industrial Portfolio - Trust located in Dallas-Plano-Irving, TX-5.93% Washington-Arlington-Alexandria, DC-VA-MD-WV-3.11% Lake County-Kenosha County, IL-WI-1.88% Newark, NJ-PA-1.55% metropolitan area. Occupancy at the subject was 87%. The major tenants included Amazon.com (6.27%) and DHL Airways (5.94%). The second largest loan of the pool (7.7%) is secured by Coleman Highline located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Roku Inc. (100.00%). The third largest loan of the pool (7.2%) is secured by Amazon Industrial Portfolio located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Amazon.com (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.59% and 6 months as of 12/15/2020, respectively. There are a total of 40 loans and 175 properties in the portfolio. The appraisal LTV was approximately 53.6% compared to the Original loan to value (LTV), which was approximately 52.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.60x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.



Occupancy Distribution (%)





EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
