Transaction Summary

The transaction closed on Jan 31 2018 and matures in Dec 2029. The pool's current aggregate principal balance is \$1157.6 million compared to \$1166.6 million at close.

The largest loan of the pool (6.0%) is secured by 90 Hudson located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Lord Abbett & Co. (60.55%) and Charles Komar & Sons Inc (36.91%). The second largest loan of the pool (4.9%) is secured by Valencia Town Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 97%. The major tenants included PRINCESS CRUISE LINES LTD (78.65%) and Morgan Stanley (2.32%). The third largest loan of the pool (5.0%) is secured by The Woods located in metropolitan area. Occupancy at the subject was 93%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.13% and 35 months as of 10/15/2020, respectively. There are a total of 49 loans and 173 properties in the portfolio. The appraisal LTV was approximately 56.8% compared to the Original loan to value (LTV), which was approximately 57.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.47x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 4% to 33% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 4% to 33%. There were 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 3 assets (6% of total balance) with NOI debt yield between 6% and 8%, 15 assets (31% of total balance) with NOI debt yield between 8% and 10%, 13 assets (24% of total balance) with NOI debt yield between 10% and 12%, 9 assets (18% of total balance) with NOI debt yield between 12% and 14%, 5 assets (13% of total balance) with NOI debt yield between 14% and 16%, 1 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 24% and 26%, 1 assets (1% of total balance) with NOI debt yield between 32% and 34%

There were 1 assets (1.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 10 assets (10.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 13 assets (23.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (24.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (21.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (8.0% of total balance) with NCF DSCR between 3.0x and 3.5x, 3 assets (3.6% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (3.1% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (5.0% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from 0.0x to 5.5x. There are 1 assets (1.3% of total balance) with DSCR between 0.0x and 0.5x, 8 assets (9.2% of total balance) with DSCR between 1.0x and 1.5x, 9 assets (7.8% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (39.7% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (13.5% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (12.5% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (4.7% of total balance) with DSCR between 3.5x and 4.0x, 3 assets (6.3% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (5.0% of total balance) with DSCR between 5.0x and 5.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
