### **Transaction Summary**

The transaction closed on Jan 31 2018 and matures in Dec 2029. The pool's current aggregate principal balance is \$1156.7 million compared to \$1166.6 million at close.

The largest loan of the pool (6.1%) is secured by 90 Hudson located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Lord Abbett & Co. (60.55%) and Charles Komar & Sons Inc (36.91%). The second largest loan of the pool (4.9%) is secured by Valencia Town Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 97%. The major tenants included PRINCESS CRUISE LINES LTD (78.65%) and Morgan Stanley (2.32%). The third largest loan of the pool (5.0%) is secured by The Woods located in metropolitan area. Occupancy at the subject was 93%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.13% and 37 months as of 12/15/2020, respectively. There are a total of 49 loans and 173 properties in the portfolio. The appraisal LTV was approximately 56.8% compared to the Original loan to value (LTV), which was approximately 57.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.48x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



**Type Concentration** 





Occupancy Distribution (%)





Among assets in the portfolio, there are 19 properties (14% of total balance) located in California, 32 properties (10% of total balance) in Texas, 3 properties (7% of total balance) in New York, 7 properties (6% of total balance) in Michigan, 2 properties (6% of total balance) in Washington DC, 8 properties (5% of total balance) in North Carolina and 8 properties (5% of total balance) in Indiana. Other properties are located in the state of Pennsylvania, Maryland, Minnesota, Illinois, Florida, Connecticut, Massachusetts, Ohio, Wisconsin, Arizona, Virginia, Missouri, Alabama, Georgia, Louisiana, Colorado, Iowa, Kentucky, South Carolina, Nevada, Oklahoma, Washington, Oregon, Wyoming and Arkansas.

Among all the assets in the portfolio, 2 assets (5% of total balance) had LTVs between 20% and 30%, 1 assets (4% of total balance) with LTVs between 30% and 40%, 6 assets (17% of total balance) with LTVs between 40% and 50%, 10 assets (24% of total balance) with LTVs between 50% and 60%, 28 assets (47% of total balance) with LTVs between 50% and 60%, and 70% and 2 assets (2% of total balance) with LTVs between 70% and 80%.








Most recent net operating income debt yield ranged from 4% to 37% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 4% to 37%. There were 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 3 assets (6% of total balance) with NOI debt yield between 6% and 8%, 15 assets (31% of total balance) with NOI debt yield between 8% and 10%, 13 assets (24% of total balance) with NOI debt yield between 10% and 12%, 9 assets (18% of total balance) with NOI debt yield between 12% and 14%, 5 assets (13% of total balance) with NOI debt yield between 14% and 16%, 1 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 24% and 26%, 1 assets (1% of total balance) with NOI debt yield between 36% and 38%





## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
