Transaction Summary

The transaction closed on Feb 27 2018 and matures in Jan 2033. The pool's current aggregate principal balance is \$1491.5 million compared to \$1507.5 million at close.

The largest loan of the pool (5.3%) is secured by Central Park of Lisle located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Armour-Eckrich Meats LLC (7.65%) and Kantar LLC (5.76%). The second largest loan of the pool (4.5%) is secured by Promenade Shops at Aventura located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 99%. The major tenants included Marshall's (16.58%) and Winn Dixie (12.31%). The third largest loan of the pool (4.6%) is secured by Apple Campus 3 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Apple Inc (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.21% and 36 months as of 12/15/2020, respectively. There are a total of 57 loans and 67 properties in the portfolio. The appraisal LTV was approximately 62.6% compared to the Original loan to value (LTV), which was approximately 57.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.19x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 2% to 33% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from 2% to 33%. There were 1 assets (3% of total balance) with NOI debt yield between 2% and 4%, 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 4 assets (12% of total balance) with NOI debt yield between 6% and 8%, 11 assets (22% of total balance) with NOI debt yield between 8% and 10%, 19 assets (21% of total balance) with NOI debt yield between 10% and 12%, 12 assets (17% of total balance) with NOI debt yield between 12% and 14%, 5 assets (12% of total balance) with NOI debt yield between 14% and 16%, 3 assets (9% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 32% and 34%

There were 1 assets (3.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 4 assets (8.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 27 assets (34.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (27.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (16.7% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (5.4% of total balance) with NCF DSCR between 4.5x and 1 assets (3.9% of total balance) with NCF DSCR between 4.5x and 5.0x. The most recent weighted average NCF DSCR was 2.2x.







DSCRs ranged from 0.5x to 5.5x.There are 1 assets (3.0% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (8.6% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (24.6% of total balance) with DSCR between 1.5x and 2.0x, 16 assets (28.0% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (21.8% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (6.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (3.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (3.9% of total balance) with DSCR between 5.0x and 5.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
