Transaction Summary

The transaction closed on Apr 10 2018 and matures in Jan 2033. The pool's current aggregate principal balance is \$1079.4 million compared to \$1093.2 million at close.

The largest loan of the pool (5.7%) is secured by 6420 Wilshire located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 79%. The major tenants included Ranker Inc. (11.86%) and Stun Creative LLC (9.45%). The second largest loan of the pool (5.6%) is secured by EOS 21 located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The third largest loan of the pool (4.6%) is secured by The SoCal Portfolio located in Los Angeles-Long Beach-Glendale, CA-33.22% Anaheim-Santa Ana-Irvine, CA-16.36% metropolitan area. Occupancy at the subject was 92%. The major tenants included CANDOR-AGS INC (5.70%) and THE CAPITAL GROUP COMPANIES (4.02%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.57% and 34 months as of 12/10/2020, respectively. There are a total of 45 loans and 88 properties in the portfolio. The appraisal LTV was approximately 59.7% compared to the Original loan to value (LTV), which was approximately 60.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.96x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.



Type Concentration








LTV Distribution (%)

Local Distribution

Among assets in the portfolio, there are 31 properties (23% of total balance) located in California, 3 properties (8% of total balance) in New York, 5 properties (8% of total balance) in Florida, 2 properties (7% of total balance) in Massachusetts, 6 properties (6% of total balance) in Illinois, 2 properties (6% of total balance) in Michigan, 2 properties (6% of total balance) in North Carolina and 3 properties (6% of total balance) in New Jersey. Other properties are located in the state of Virginia, Arizona, Minnesota, Ohio, Pennsylvania, Texas, Georgia, Alabama, Indiana, Maryland, Utah, Mississippi, Oklahoma and Nevada.





Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 11.0%. NOI debt yield ranged from 6% to 21%. There were 8 assets (20% of total balance) with NOI debt yield between 6% and 8%, 10 assets (22% of total balance) with NOI debt yield between 8% and 10%, 17 assets (32% of total balance) with NOI debt yield between 10% and 12%, 5 assets (10% of total balance) with NOI debt yield between 12% and 14%, 3 assets (9% of total balance) with NOI debt yield between 14% and 16%, 1 assets (4% of total balance) with NOI debt yield between 16% and 18%, 1 assets (2% of total balance) with NOI debt yield between 20% and 22%





DSCRs ranged from 0.0x to 4.5x. There are 6 assets (20.1% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (5.7% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (39.2% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (11.4% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (17.2% of total balance) with DSCR between 2.0x and 2.5x, and 3.0x, 1 assets (4.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (2.3% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (4.0% of total balance) that have maturity dates between 2022/1 and 2022/6, 5 assets (10.6% of total balance) that have maturity dates between 2023/1 and 2023/6, 1 assets (5.6% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (0.6% of total balance) that have maturity dates between 2025/1 and 2025/6, 4 assets (7.4% of total balance) that have maturity dates between 2027/7 and 2027/12, 32 assets (67.7% of total balance) that have maturity dates between 2028/1 and 2028/6 and 1 assets (4.2% of total balance) that have maturity dates between 2033/1 and 2033/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
