Transaction Summary

The transaction closed on Feb 28 2020 and matures in Sep 2033. The pool's current aggregate principal balance is \$660.0 million compared to \$660.0 million at close.

The largest loan of the pool (9.8%) is secured by 1633 Broadway - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Allianz Asset Management of America L.P. (12.53%) and WMG Acquisition Corp (11.47%). The second largest loan of the pool (8.4%) is secured by F5 Tower - Trust located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 100%. The largest tenant was F5 Networks, Inc. (100.00%). The third largest loan of the pool (8.3%) is secured by Bellagio Hotel and Casino - Trust located in metropolitan area. Occupancy at the subject was 95%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.26% and 10 months as of 10/15/2020, respectively. There are a total of 13 loans and 45 properties in the portfolio. The appraisal LTV was approximately 36.4% compared to the Original loan to value (LTV), which was approximately 36.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 3.21x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.



Type Concentration








Occupancy Distribution (%)







Most recent net operating income debt yield ranged from 8% to 29% with a weighted average NOI debt yield of 14.2%. NOI debt yield ranged from 8% to 29%. There were 3 assets (21% of total balance) with NOI debt yield between 8% and 10%, 4 assets (32% of total balance) with NOI debt yield between 10% and 12%, 3 assets (24% of total balance) with NOI debt yield between 12% and 14%, 1 assets (8% of total balance) with NOI debt yield between 16% and 18%, 1 assets (8% of total balance) with NOI debt yield between 20% and 22%, 1 assets (8% of total balance) with NOI debt yield between 28% and 30%

NCF DSCR ranged from 0.0x to 4.0x. There were 10 assets (74.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (18.1% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (7.6% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 3.2x.





DSCRs ranged from 0.0x to 5.0x. There are 11 assets (84.1% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (8.3% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (7.6% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 3.7x.

There are 1 assets (6.8% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (7.6% of total balance) that have maturity dates between 2026/7 and 2026/12, 7 assets (53.0% of total balance) that have maturity dates between 2029/7 and 2029/12, 3 assets (24.2% of total balance) that have maturity dates between 2030/1 and 2030/6 and 1 assets (8.4% of total balance) that have maturity dates between 2033/7 and 2033/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
