Transaction Summary

The transaction closed on May 22 2020 and matures in Sep 2036. The pool's current aggregate principal balance is \$794.1 million compared to \$794.1 million at close.

The largest loan of the pool (6.9%) is secured by Chase Center Tower I - Pooled located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was UBER TECHNOLOGIES INC (100.00%). The second largest loan of the pool (10.5%) is secured by Chase Center Tower I - Rake located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was UBER TECHNOLOGIES INC (100.00%). The third largest loan of the pool (5.9%) is secured by Chase Center Tower II - Pooled located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Uber Technology (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.35% and 10 months as of 12/15/2020, respectively. There are a total of 14 loans and 72 properties in the portfolio. The appraisal LTV was approximately 38.2% compared to the Original loan to value (LTV), which was approximately 38.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 3.08x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 96%.

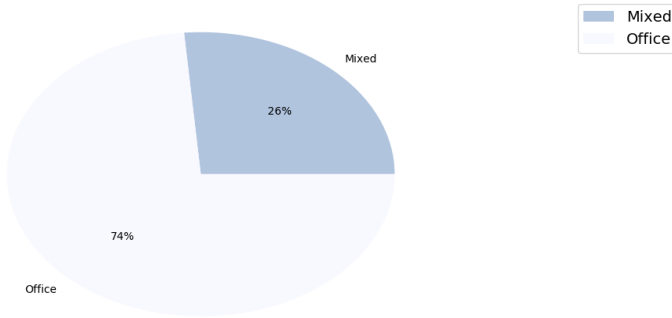

Among assets in the portfolio, Mixed properties accounted for 26% of total balance and Office properties accounted for 74% of total balance.

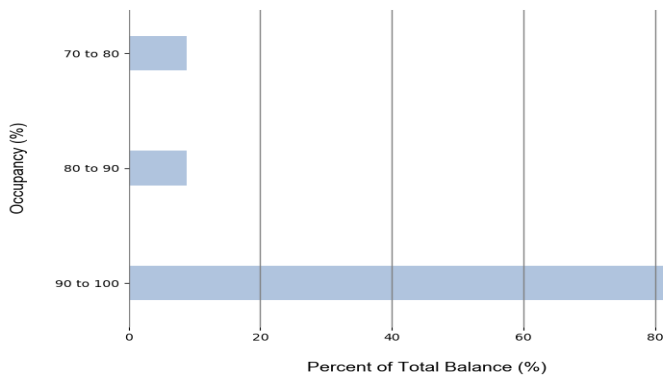

Occupancy Distribution (%)

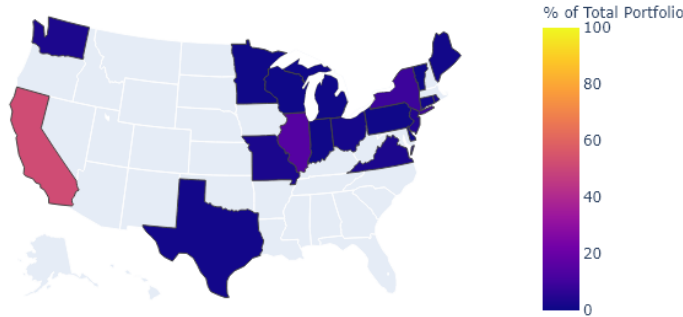

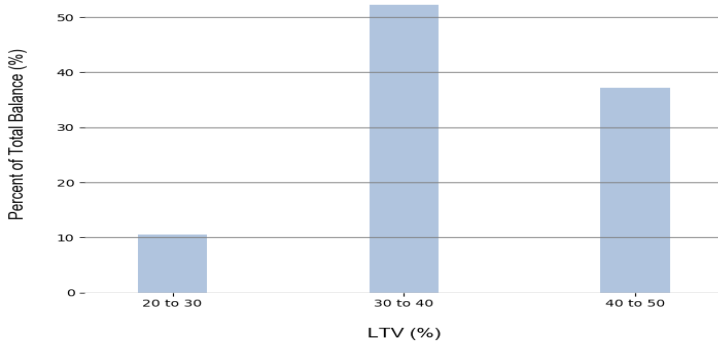
Local Distribution

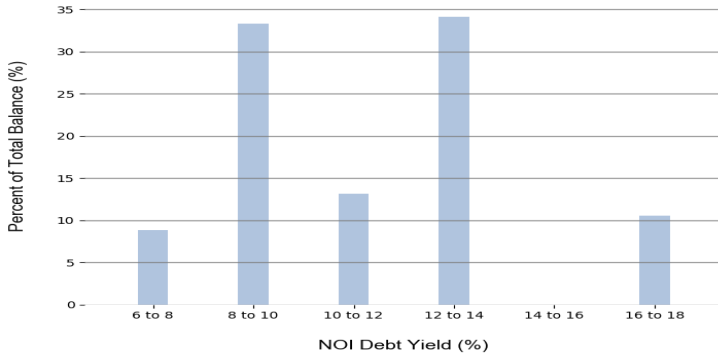

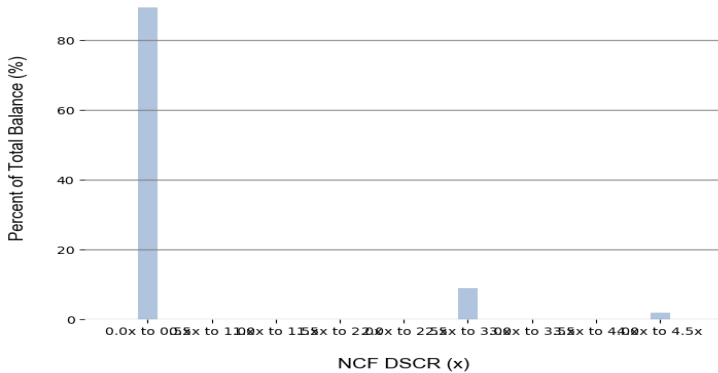
NOI Debt Yield (%)

There were 1 assets (9% of total balance) with NOI debt yield between 6% and 8%, 4 assets (33% of total balance) with NOI debt yield between 8% and 10%, 2 assets (13% of total balance) with NOI debt yield between 10% and 12%, 5 assets (34% of total balance) with NOI debt yield between 12% and 14%, 2 assets (11% of total balance) with NOI debt yield between 16% and 18%

Net Cash Flow DSCR (x)

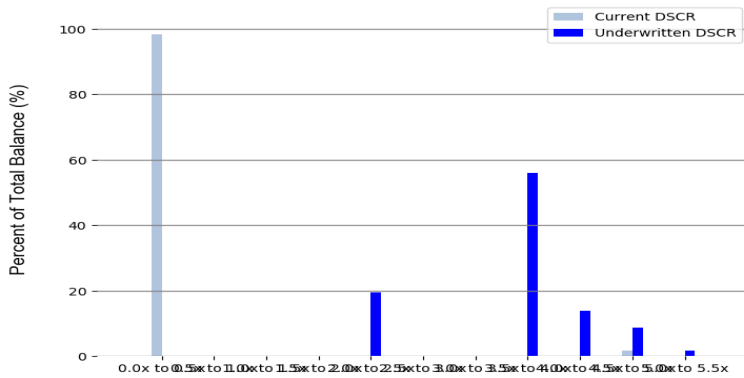

There were 12 assets (89.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (8.8% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (1.8% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 3.1x.

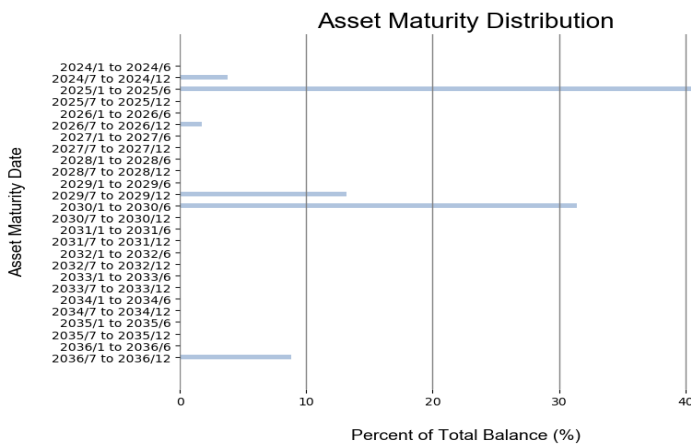

DSCRs ranged from 0.0x to 5.0x. There are 13 assets (98.2% of total balance) with DSCR between 0.0x and 0.5x and 1 assets (1.8% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 4.6x.

Maturity



There are 1 assets (3.8% of total balance) that have maturity dates between 2024/7 and 2024/12, 5 assets (41.1% of total balance) that have maturity dates between 2025/1 and 2025/6, 1 assets (1.8% of total balance) that have maturity dates between 2026/7 and 2026/12, 2 assets (13.2% of total balance) that have maturity dates between 2029/7 and 2029/12, 4 assets (31.4% of total balance) that have maturity dates between 2030/1 and 2030/6 and 1 assets (8.8% of total balance) that have maturity dates between 2036/7 and 2036/12.

Sensitivity Analysis

Summary

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
