### **Transaction Summary**

The transaction closed on Apr 11 2019 and matures in Jan 2033. The pool's current aggregate principal balance is \$1252.2 million compared to \$1256.2 million at close.

The largest loan of the pool (6.0%) is secured by 3 Columbus Circle - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Young & Rubicam, Inc. (49.78%) and Emerge 212 3CC LLC (7.61%). The second largest loan of the pool (8.4%) is secured by 3 Columbus Circle - Rake located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Young & Rubicam, Inc. (49.78%) and Emerge 212 3CC LLC (7.61%). The third largest loan of the pool (4.8%) is secured by 3 Park Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 86%. The major tenants included Houghton Mifflin (8.08%) and Houghton (5.53%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.81% and 22 months as of 12/15/2020, respectively. There are a total of 47 loans and 99 properties in the portfolio. The appraisal LTV was approximately 55.8% compared to the Original loan to value (LTV), which was approximately 55.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.90x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.



Type Concentration











Most recent net operating income debt yield ranged from 4% to 29% with a weighted average NOI debt yield of 10.5%. NOI debt yield ranged from 4% to 29%. There were 2 assets (4% of total balance) with NOI debt yield between 4% and 6%, 9 assets (16% of total balance) with NOI debt yield between 6% and 8%, 17 assets (37% of total balance) with NOI debt yield between 8% and 10%, 9 assets (26% of total balance) with NOI debt yield between 10% and 12%, 6 assets (10% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 1 assets (3% of total balance) with NOI debt yield between 24% and 26%, 1 assets (3% of total balance) with NOI debt yield between 28% and 30%

NCF DSCR ranged from 0.0x to 7.0x. There were 5 assets (6.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 16 assets (24.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (47.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (11.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (5.7% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.4% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (3.2% of total balance) with NCF DSCR between 7.0x and 7.5x. The most recent weighted average NCF DSCR was 1.9x.







DSCRs ranged from 0.0x to 7.5x. There are 5 assets (6.7% of total balance) with DSCR between 0.0x and 0.5x, 12 assets (19.7% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (36.6% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (26.5% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (6.9% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (3.2% of total balance) with DSCR between 7.0x and 7.5x. The most recent weighted average DSCR is 2.0x.

There are 3 assets (11.1% of total balance) that have maturity dates between 2024/1 and 2024/6, 4 assets (13.2% of total balance) that have maturity dates between 2028/7 and 2028/12, 39 assets (73.4% of total balance) that have maturity dates between 2029/1 and 2029/6 and 1 assets (2.3% of total balance) that have maturity dates between 2033/1 and 2033/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
