Transaction Summary

The transaction closed on Nov 21 2019 and matures in Nov 2029. The pool's current aggregate principal balance is \$1464.5 million compared to \$1468.7 million at close.

The largest loan of the pool (5.0%) is secured by Watergate Office Building located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 87%. The major tenants included National Trust for Historic Preservation (17.54%) and The George Washington University (16.97%). The second largest loan of the pool (4.1%) is secured by 225 Bush - Pooled located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included Twitch Interactive (14.49%) and LiveRamp, Inc (13.23%). The third largest loan of the pool (10.0%) is secured by 225 Bush - NonPooled located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included Twitch Interactive (14.49%) and LiveRamp, Inc (13.23%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.74% and 14 months as of 12/15/2020, respectively. There are a total of 54 loans and 113 properties in the portfolio. The appraisal LTV was approximately 59.8% compared to the Original loan to value (LTV), which was approximately 60.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.60x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 95%.



Type Concentration







Among assets in the portfolio, there are 12 properties (30% of total balance) located in Massachusetts, 6 properties (13% of total % of Total Portfolio balance) in California, 10 properties (13% of total balance) in New York, 21 properties (5% of total balance) in New Jersey, 3 properties (4% of total balance) in Ohio, 7 properties (4% of total balance) in Texas, 2 properties (4% of total balance) in Washington DC and 3 properties (3% of total balance) in Nevada. Other properties are located in the state of Kansas, North Carolina, Florida, Virginia, Arizona, Wisconsin, Illinois, Washington, Michigan, New Hampshire, Alabama, Georgia, Oregon, Connecticut, Alaska, South Carolina, Pennsylvania, Rhode Island, Maine and Vermont.

Among all the assets in the portfolio, 5 assets (15% of total balance) had LTVs between 30% and 40%, 2 assets (2% of total balance) with LTVs between 40% and 50%, 10 assets (23% of total balance) with LTVs between 50% and 60%, 30 assets (51% of total balance) with LTVs between 60% and 70% and 7 assets (9% of total balance) with LTVs between 70% and 80%.




NOI Debt Yield (%)

Most recent net operating income debt yield ranged from 2% to 19% with a weighted average NOI debt yield of 8.3%. NOI debt yield ranged from 2% to 19%. There were 1 assets (5% of total balance) with NOI debt yield between 2% and 4%, 6 assets (15% of total balance) with NOI debt yield between 4% and 6%, 12 assets (23% of total balance) with NOI debt yield between 6% and 8%, 21 assets (31% of total balance) with NOI debt yield between 8% and 10%, 7 assets (15% of total balance) with NOI debt yield between 10% and 12%, 5 assets (10% of total balance) with NOI debt yield between 12% and 14%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%

There were 30 assets (54.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (7.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 7 assets (8.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 7 assets (15.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 2 assets (3.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (8.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.5% of





DSCRs ranged from 0.0x to 16.0x. There are 30 assets (54.3% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (7.2% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (5.0% of total balance) with DSCR between 1.0x and 1.5x, 9 assets (18.1% of total balance) with DSCR between 1.5x and 2.0x, 3 assets (3.5% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (5.9% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.5% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (2.7% of total balance) with DSCR between 15.5x and 16.0x. The most recent weighted average DSCR is 2.7x.

There are 8 assets (27.8% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (3.9% of total balance) that have maturity dates between 2026/7 and 2026/12, 1 assets (2.7% of total balance) that have maturity dates between 2029/1 and 2029/6 and 44 assets (65.6% of total balance) that have maturity dates between 2029/7 and 2029/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
