### **Transaction Summary**

The transaction closed on Apr 19 2017 and matures in Apr 2027. The pool's current aggregate principal balance is \$981.4 million compared to \$1009.3 million at close.

The largest loan of the pool (7.0%) is secured by D.C. Office Portfolio located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 87%. The major tenants included Questex Media Group LLC (3.81%) and New Venture Fund (3.19%). The second largest loan of the pool (6.3%) is secured by The Summit Birmingham located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Belk's (24.00%) and RSM US LLP (5.24%). The third largest loan of the pool (6.1%) is secured by One West 34th Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included CVS (7.25%) and OLIVIA MILLER INC. (6.28%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.84% and 46 months as of 12/15/2020, respectively. There are a total of 48 loans and 64 properties in the portfolio. The appraisal LTV was approximately 57.7% compared to the Original loan to value (LTV), which was approximately 59.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.87x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.






#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 19% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 4% to 19%. There were 1 assets (6% of total balance) with NOI debt yield between 4% and 6%, 5 assets (13% of total balance) with NOI debt yield between 6% and 8%, 7 assets (20% of total balance) with NOI debt yield between 8% and 10%, 16 assets (15% of total balance) with NOI debt yield between 10% and 12%, 9 assets (20% of total balance) with NOI debt yield between 12% and 14%, 5 assets (10% of total balance) with NOI debt yield between 14% and 16%, 3 assets (8% of total balance) with NOI debt yield between 16% and 18% and 2 assets (8% of total balance) with NOI debt yield between 18% and 20%.

NCF DSCR ranged from 0.0x to 3.0x. There were 1 assets (0.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 15 assets (26.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 20 assets (42.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (18.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (7.5% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (4.2% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.9x







DSCRs ranged from 0.0x to 3.5x.There are 1 assets (0.7% of total balance) with DSCR between 0.0x and 0.5x, 9 assets (11.7% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (39.8% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (26.7% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (16.9% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (4.2% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 2.0x.

There are 1 assets (5.3% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (4.2% of total balance) that have maturity dates between 2025/1 and 2025/6, 5 assets (5.9% of total balance) that have maturity dates between 2026/7 and 2026/12 and 41 assets (84.6% of total balance) that have maturity dates between 2027/1 and 2027/6.

### EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
