# **Transaction Summary**

The transaction closed on Apr 19 2017 and matures in Apr 2027. The pool's current aggregate principal balance is \$918.8 million compared to \$954.3 million at close.

The largest loan of the pool (7.5%) is secured by D.C. Office Portfolio located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 73%. The major tenants included New Venture Fund (4.22%) and Strategic Organizing Center (2.99%). The second largest loan of the pool (6.7%) is secured by The Summit Birmingham located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Belk's (24.00%) and RSM US LLP (5.24%). The third largest loan of the pool (6.5%) is secured by One West 34th Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 83%. The major tenants included CVS (7.25%) and OLIVIA MILLER INC. (6.28%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.82% and 61 months as of 03/15/2022, respectively. There are a total of 47 loans and 63 properties in the portfolio. The appraisal LTV was approximately 57.0% compared to the Original loan to value (LTV), which was approximately 58.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.52x. As of 03/15/2022, 4.51% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





# Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from -6% to 21% with a weighted average NOI debt yield of 9.0%. NOI debt yield ranged from -6% to 21%. There were 1 assets (4.9% of total balance) with NCF DSCR between -1.0x and -0.5x, 3 assets (5.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (9.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (20.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (29.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (19.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (6.0% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (4.5% of total balance) with NCF DSCR between 3.0x and 3.5x. 



There are 1 assets (4.9% of total balance) with DSCR between -0.5x and 0.0x, 3 assets (5.3% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (9.0% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (14.8% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (33.3% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (21.7% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (6.6% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (4.5% of total balance) with DSCR between 3.0x and 3.5x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
