### **Transaction Summary**

The transaction closed on Apr 19 2017 and matures in Apr 2027. The pool's current aggregate principal balance is \$918.1 million compared to \$954.3 million at close.

The largest loan of the pool (7.5%) is secured by D.C. Office Portfolio located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 73%. The major tenants included New Venture Fund (4.22%) and Strategic Organizing Center (2.99%). The second largest loan of the pool (6.7%) is secured by The Summit Birmingham located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Belk's (24.00%) and RSM US LLP (5.24%). The third largest loan of the pool (6.5%) is secured by One West 34th Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 83%. The major tenants included CVS (7.25%) and OLIVIA MILLER INC. (6.28%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.82% and 62 months as of 04/15/2022, respectively. There are a total of 47 loans and 63 properties in the portfolio. The appraisal LTV was approximately 56.8% compared to the Original loan to value (LTV), which was approximately 58.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.54x. As of 04/15/2022, 4.51% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.



Type Concentration













There are 1 assets (4.9% of total balance) with DSCR between -0.5x and 0.0x, 3 assets (5.3% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (7.1% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (14.8% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (35.2% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (19.9% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (19.9% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (8.3% of total balance) with DSCR between 3.0x and 3.5x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.
