Transaction Summary

The transaction closed on Sep 28 2017 and matures in Sep 2029. The pool's current aggregate principal balance is \$1188.2 million compared to \$1209.0 million at close.

The largest loan of the pool (9.4%) is secured by General Motors Building - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Weil, Gotshal & Manges (24.62%) and Aramis (15.07%). The second largest loan of the pool (9.3%) is secured by 222 Second Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Linked Incorporated (32.86%) and Linked Incorporated (29.93%). The third largest loan of the pool (7.2%) is secured by University Center Chicago located in metropolitan area. Occupancy at the subject was 95%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.07% and 40 months as of 12/15/2020, respectively. There are a total of 64 loans and 82 properties in the portfolio. The appraisal LTV was approximately 51.0% compared to the Original loan to value (LTV), which was approximately 51.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.46x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.








Local Distribution





There were 3 assets (0.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 7 assets (5.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (12.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (28.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 13 assets (24.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (12.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (10.5% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (5.7% of total balance) with NCF DSCR between 8.0x and 8.5x. 



DSCRs ranged from 0.0x to 9.0x. There are 3 assets (0.5% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (1.2% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (15.0% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (28.0% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (13.2% of total balance) with DSCR between 2.0x and 2.5x, 13 assets (25.4% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (10.4% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.6% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (5.7% of total balance) with DSCR between 8.5x and 9.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
