## Transaction Summary

The transaction closed on Sep 28 2017 and matures in Sep 2029. The pool's current aggregate principal balance is \$1176.3 million compared to \$1209.0 million at close.

The largest loan of the pool (9.5%) is secured by General Motors Building - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 89%. The major tenants included Weil, Gotshal & Manges (24.62%) and Aramis (15.07%). The second largest loan of the pool (9.4%) is secured by 222 Second Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Linked Incorporated (34.63%) and Linked Incorporated (32.86%). The third largest loan of the pool (7.3%) is secured by University Center Chicago located in metropolitan area. Occupancy at the subject was 91%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.07% and 55 months as of 03/15/2022, respectively. There are a total of 64 loans and 82 properties in the portfolio. The appraisal LTV was approximately 50.3% compared to the Original loan to value (LTV), which was approximately 51.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.23x. As of 03/15/2022, 3.10% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

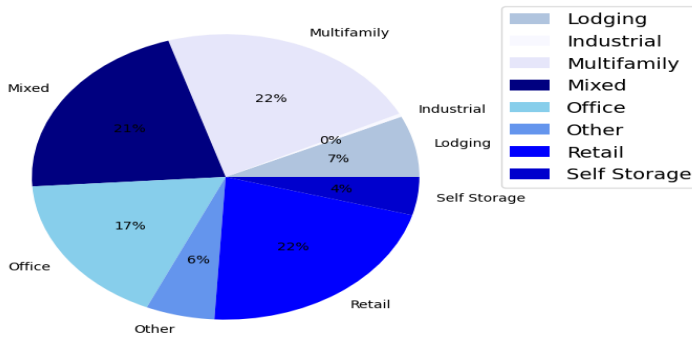

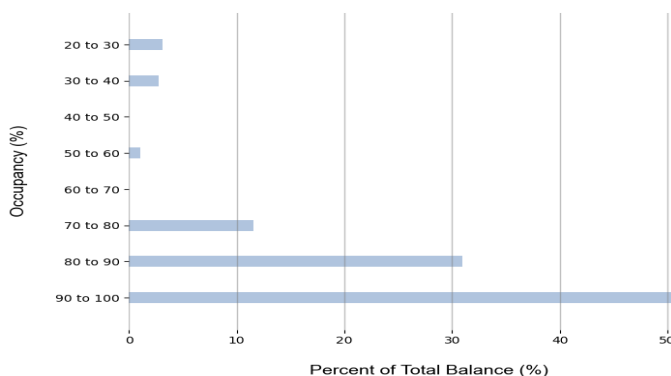

### Occupancy Distribution (%)



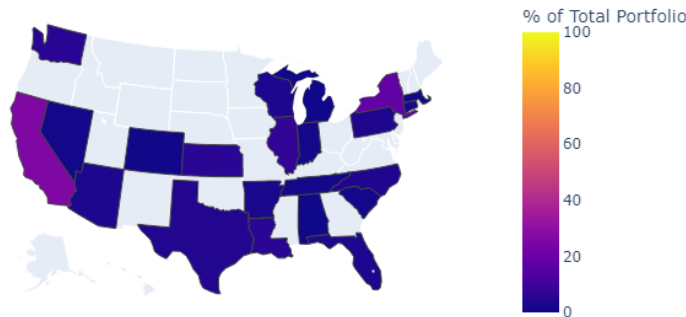

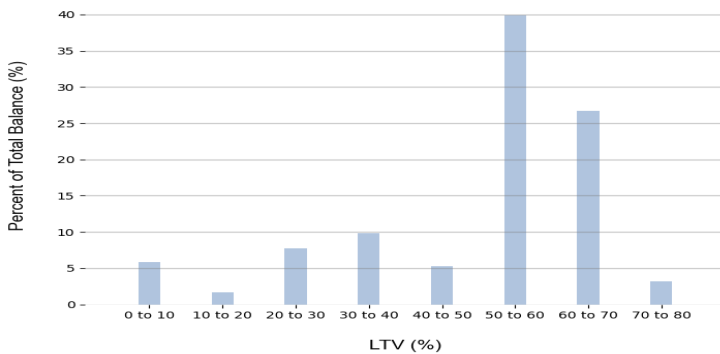
Local Distribution

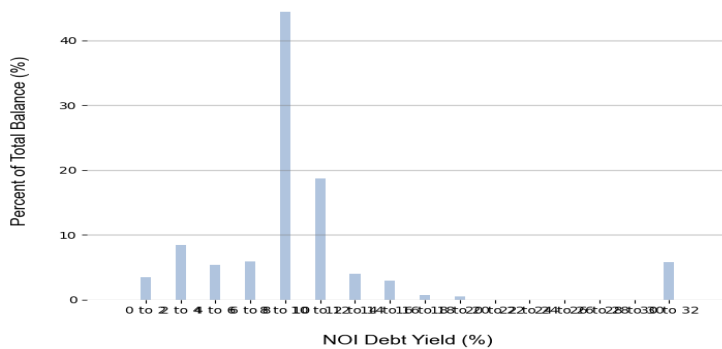

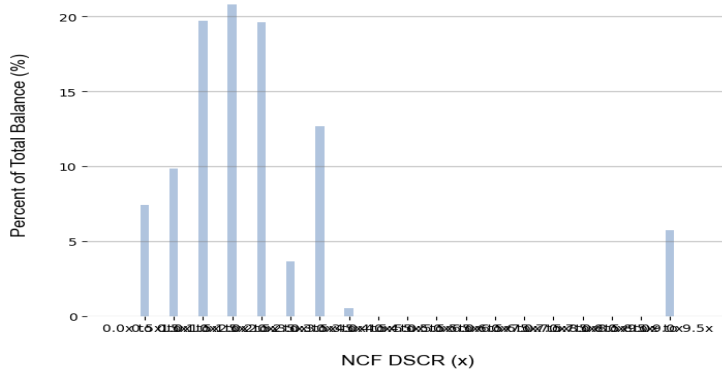
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

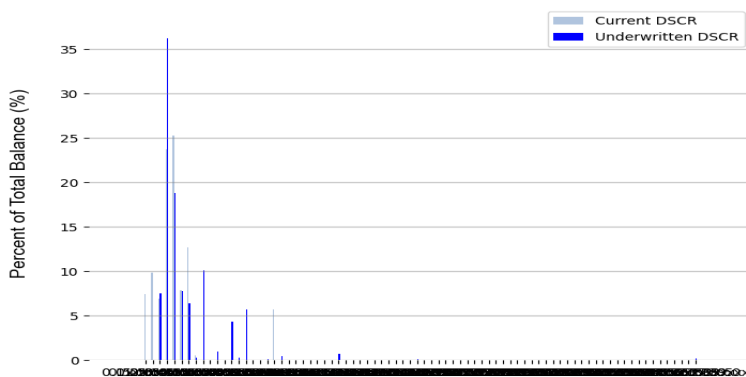

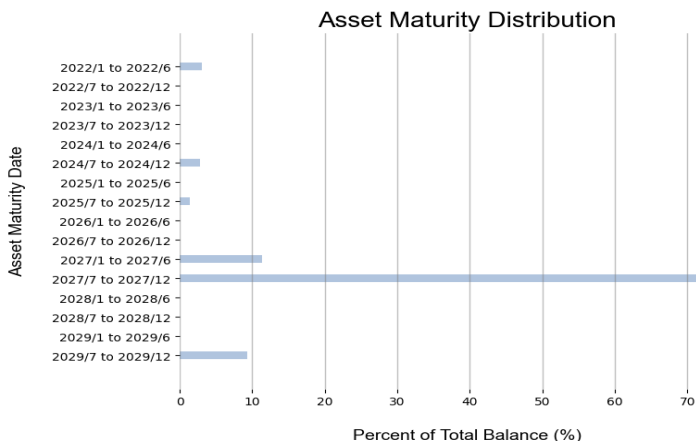

There are 6 assets (7.4% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (9.9% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (6.9% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (23.7% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (25.3% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (7.9% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (12.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.5% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (5.7% of total balance) with DSCR between 9.0x and 9.5x. There are 1 assets (36.4% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (32.9% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (16.6% of total balance) that have maturity dates between 2025/7 and 2025/12, 4 assets (133.8% of total balance) that have maturity dates between 2027/1 and 2027/6, 56 assets (846.5% of total balance) that have maturity dates between 2027/7 and 2027/12 and 1 assets (110.0% of total balance) that have maturity dates between 2029/7 and 2029/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

### **3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:**

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


