Transaction Summary

The transaction closed on Nov 15 2017 and matures in Sep 2029. The pool's current aggregate principal balance is \$1121.4 million compared to \$1131.0 million at close.

The largest loan of the pool (9.8%) is secured by Griffin Portfolio located in Dallas-Plano-Irving, TX-22.68% Seattle-Bellevue-Everett, WA-3.76% metropolitan area. Occupancy at the subject was 97%. The major tenants included Restoration Hardware (40.48%) and State Farm Insurance Company (13.57%). The second largest loan of the pool (8.9%) is secured by Park Square located in Boston, MA metropolitan area. Occupancy at the subject was 90%. The major tenants included 31 ST JAMES AVE TENANT (27.20%) and Bay State College Inc (7.08%). The third largest loan of the pool (8.2%) is secured by The New School located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.09% and 36 months as of 10/15/2020, respectively. There are a total of 50 loans and 83 properties in the portfolio. The appraisal LTV was approximately 55.8% compared to the Original loan to value (LTV), which was approximately 56.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.48x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)













DSCRs ranged from 0.0x to 6.0x. There are 1 assets (0.3% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.5% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (4.9% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (33.8% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (18.1% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (25.3% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.2% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (6.2% of total balance) with DSCR between 4.5x and 5.0x, 1 assets (0.8% of total balance) with DSCR between 5.0x and 5.5x and 1 assets (7.1% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
