## Transaction Summary

The transaction closed on Nov 15 2017 and matures in Sep 2029. The pool's current aggregate principal balance is \$1120.7 million compared to \$1131.0 million at close.

The largest loan of the pool (9.8%) is secured by Griffin Portfolio located in Dallas-Plano-Irving, TX-22.68% Seattle-Bellevue-Everett, WA-3.76% metropolitan area. Occupancy at the subject was 97%. The major tenants included Restoration Hardware (40.48%) and State Farm Insurance Company (13.57%). The second largest loan of the pool (8.9%) is secured by Park Square located in Boston, MA metropolitan area. Occupancy at the subject was 90%. The major tenants included 31 ST JAMES AVE TENANT (27.20%) and Bay State College Inc (7.08%). The third largest loan of the pool (8.2%) is secured by The New School located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.09% and 38 months as of 12/15/2020, respectively. There are a total of 50 loans and 83 properties in the portfolio. The appraisal LTV was approximately 55.8% compared to the Original loan to value (LTV), which was approximately 56.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.48x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

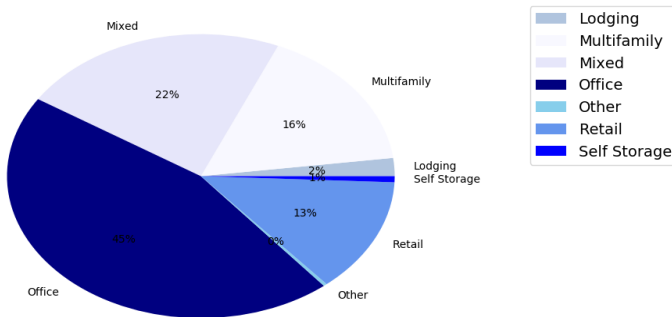

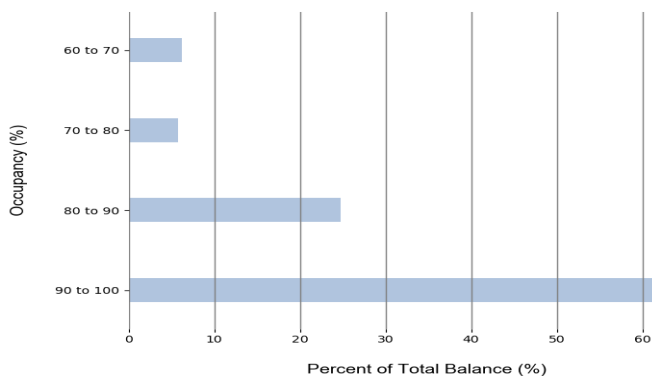

Occupancy Distribution (%)

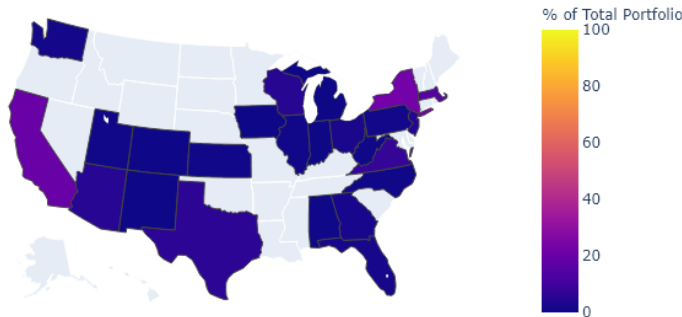

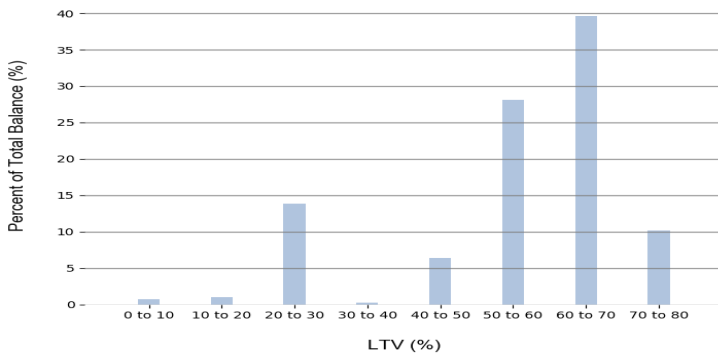
Local Distribution

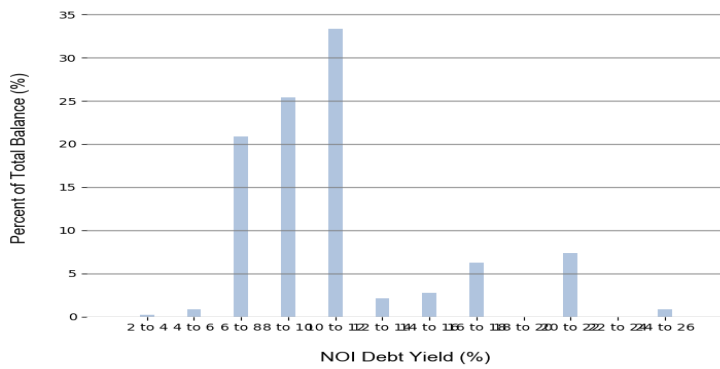

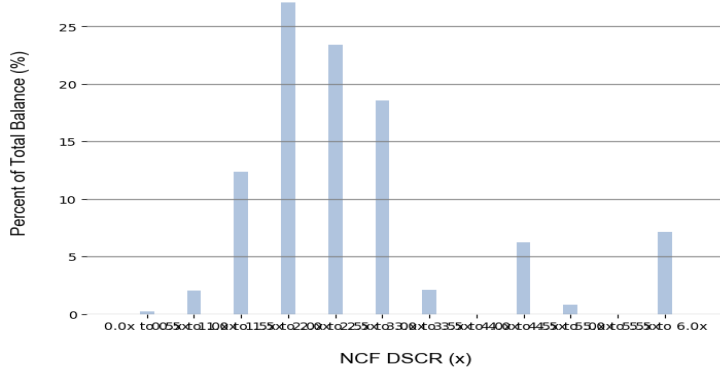
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

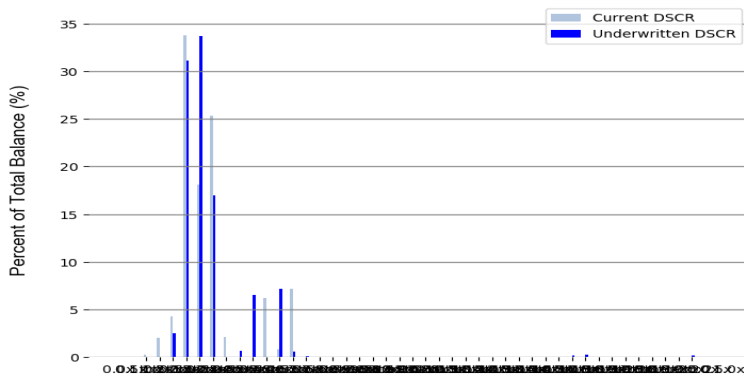

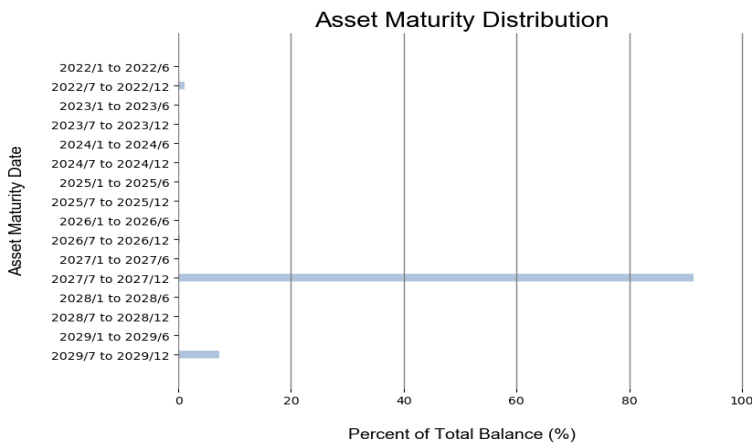

There are 1 assets (0.3% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (2.1% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (4.3% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (33.8% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (18.1% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (25.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (2.1% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (6.2% of total balance) with DSCR between 4.5x and 5.0x, 1 assets (0.8% of total balance) with DSCR between 5.0x and 5.5x and 1 assets (7.1% of total balance) with DSCR between 5.5x and 6.0x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
