## **Transaction Summary**

The transaction closed on Apr 26 2018 and matures in Apr 2031. The pool's current aggregate principal balance is \$678.0 million compared to \$688.4 million at close.

The largest loan of the pool (9.4%) is secured by Twelve Oaks Mall - Trust located in Warren-Troy-Farmington Hills, MI metropolitan area. Occupancy at the subject was 93%. The major tenants included Nordstrom (23.30%) and H&M (3.40%). The second largest loan of the pool (9.7%) is secured by Extra Space - TIAA Self Storage Portfolio located in Los Angeles-Long Beach-Glendale, CA-15.94% Washington-Arlington-Alexandria, DC-VA-MD-WV-13.47% Miami-Miami Beach-Kendall, FL-10.58% Silver Spring-Frederick-Rockville, MD-4.23% Philadelphia, PA-4.07% Anaheim-Santa Ana-Irvine, CA-4.00% Wilmington, DE-MD-NJ-3.58% Cambridge-Newton-Framingham, MA-3.01% Dallas-Plano-Irving, TX-2.33% metropolitan area. Occupancy at the subject was 93%. The third largest loan of the pool (9.3%) is secured by Apple Campus 3 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Apple (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.41% and 33 months as of 12/15/2020, respectively. There are a total of 42 loans and 76 properties in the portfolio. The appraisal LTV was approximately 54.2% compared to the Original loan to value (LTV), which was approximately 54.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.95x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.



Type Concentration













There are 5 assets (12.4% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (10.8% of total balance) with DSCR between 1.0x and 1.5x, 8 assets (15.2% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (40.5% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (15.4% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (4.9% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.7% of total balance) with DSCR between 4.5x and 5.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
