Transaction Summary

The transaction closed on Apr 26 2018 and matures in Apr 2031. The pool's current aggregate principal balance is \$671.3 million compared to \$688.4 million at close.

The largest loan of the pool (9.3%) is secured by Twelve Oaks Mall - Trust located in Warren-Troy-Farmington Hills, MI metropolitan area. Occupancy at the subject was 93%. The major tenants included Nordstrom (23.30%) and H&M (3.40%). The second largest loan of the pool (9.8%) is secured by Extra Space - TIAA Self Storage Portfolio located in Los Angeles-Long Beach-Glendale, CA-15.94% Washington-Arlington-Alexandria, DC-VA-MD-WV-13.47% Miami-Miami Beach-Kendall, FL-10.58% Silver Spring-Frederick-Rockville, MD-4.23% Philadelphia, PA-4.07% Anaheim-Santa Ana-Irvine, CA-4.00% Wilmington, DE-MD-NJ-3.58% Cambridge-Newton-Framingham, MA-3.01% Dallas-Plano-Irving, TX-2.33% metropolitan area. Occupancy at the subject was 96%. The third largest loan of the pool (9.4%) is secured by Apple Campus 3 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Apple (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.41% and 49 months as of 04/15/2022, respectively. There are a total of 42 loans and 76 properties in the portfolio. The appraisal LTV was approximately 53.7% compared to the Original loan to value (LTV), which was approximately 54.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.99x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
