Transaction Summary

The transaction closed on May 30 2018 and matures in Apr 2031. The pool's current aggregate principal balance is \$884.9 million compared to \$901.3 million at close.

The largest loan of the pool (9.8%) is secured by CoolSprings Galleria located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Belk's (28.60%) and H&M (3.69%). The second largest loan of the pool (10.1%) is secured by One Dulles Tower located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The largest tenant was Amazon.com (100.00%). The third largest loan of the pool (8.7%) is secured by Fair Oaks Mall - Trust located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 94%. The major tenants included Macy's (27.60%) and XXI Forever (6.60%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.45% and 30 months as of 10/15/2020, respectively. There are a total of 63 loans and 95 properties in the portfolio. The appraisal LTV was approximately 50.0% compared to the Original loan to value (LTV), which was approximately 49.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.79x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.



Type Concentration











DSCRs ranged from -0.5x to 5.0x.There are 1 assets (0.2% of total balance) with DSCR between -0.5x and 0.0x, 12 assets (10.9% of total balance) with DSCR between 0.0x and 0.5x, 8 assets (13.4% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (10.5% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (16.3% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (27.6% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (4.7% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (15.4% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (1.0% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 1.9x.

There are 2 assets (9.3% of total balance) that have maturity dates between 2023/1 and 2023/6, 58 assets (72.2% of total balance) that have maturity dates between 2028/1 and 2028/6, 1 assets (10.1% of total balance) that have maturity dates between 2029/7 and 2029/12 and 2 assets (8.5% of total balance) that have maturity dates between 2031/1 and 2031/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
